# Basso Files For Mine Inspector

Charles E Basso of Reno, mining engineer, has filed notice of his candidacy for the office of State Mine Inspector.

Mr. Basso is planning a tour of the state in the near future to talk the matter of his candidacy over with the voters. He is seeking the nomination on the Democratic ticket and will have plenty of competition for the nomination.

In his letter announcing his candidacy, Mr. Basso says, in part:

"As you already know, I have been very friendly with the prospectors of our State and a great many in your own Clark County in rendering necessary financial assistance to develop and exploit their properties. Without the prospector, we would not have the large successful producing mines our State now has.

"We are entering an era where more attention should be focused on the mineral wealth and all necessary steps should be taken to develop same. I am conscious of he fact that we as citizens of "The One Sound State" derive most of our revenue from three sources, namely, mining, agriculture and Boulder Dam power.

"As an engineer and in my capacity of State Mine Inspector, if elected to that position, I will do everything in my power to alleviate the present stagnant condition of the mineral industry in our State. I pledge myself to exercise all the duties of Mine Inspector within the scope of the statutes of our State."

The Governor's statement followed closely upon the filing of Lieutenant Governor Fred S. Alward for the post he now holds. Alward had expected to be a candidate for governor until Mr. Kirman was said to have decided to run, after which Alward filed for his present office.

### Sledge Out For Superitnendent

Leonard W. Sledge, prominent educator of Nevada and Deputy Superintendent of Public Instruction, filed as a nonpartisan candidate for the position of State Superintendent of Public Instruction on July 13. Mr. Sledge has been mentioned as a probable candidate for several months. He was appointed Deputy Superintendent in the Department of Education when the late Superintendent Chauncey W. Smith assumed the State office in 1935.

Mr. Sledge has served in the public school system of Nevada continuously since his graduation from the University of Nevada He was born in Lovelock, Nevada and received his early schooling in Lander and Eureka counties. He was an honor student for four consecutive vears and a member of Phi Kappa Phi, national honorary scholarship society. During his undergraduate career he won four scholarships and was selected as Nevada's candidate for the Rhodes Scholarship in 1930. He has done additional graduate research in education at the Universities of Nevada, Washington, and California at Los Angeles, and holds the degrees of Bachelor of Arts and Master of Arts.

Before becoming Deputy State Superintendent, Sledge had both elementary and secondary teaching experience. As Deputy Superintendent he has supervised the schools of Clark, Esmeralda, Lincoln, and southern Nye counties.

Leonard W. Sledge is a member of the Rotary Club, a director of the Las Vegas Community Theatre, a member of the Nevada State Educational Association, a member of the Nevada Historical Society, an auxiliary member for research in Nevada for the Council of Teachers of English, and is the State Extension Chairman of the Junior Chamber of Commerce and the State member of the United States Junior Chamber of Commerce Speakers' Bureau.

In seeking the position of State Superintendent of Public Instruction. Sledge stated that it is an office "that should be kept non-partisan. It requires a person of broad educational training, a complete understanding of conditions in Nevada, an experience with schools of all types and circumstantes. It is with these considerations in mind that I present my qualifications to the voters"

# Alward Files For Reelection

Mr. Alward has filled his present position since the election of 1934, and presided efficiently over the sessions of the state senate in 1935 and 1937.

### Cottonwood Tree Inoculation Off

In reply to a letter from Secretary Goerman of the Las Vegas Chamber of Commerce, Prof. F. F. Whitley, extension horticulturist of State College, New Mexico, indicates that the only preventative of cotton bearing by cottonwood trees is to select, when planting, cuttings from the male, non-cotton bearing trees only.

In reply to the request for information as to inoculation of cotton-wood trees to eliminate the nuisance of flying cotton, Prof Whitley says:

"I regret to say that at the present time we are unable to recommend means of accomplishing this end."
