Richards Cites Helpful Career

Charles L. Richards, candidate for the Democratic nomination for governor of Nevada, believes that his record for constructive service to the state and nation and his long career of helpfulness to the people during both his private and official life, give him the right to earnest and thoughtful consideration by voters of his party at the coming primary election.

Mr Richards was born in Austin, Nevada, and after receiving his early education in the schools of his native city, graduated from Sanford University with the class of 1901.

Returning to Nevada following his graduation, he was lured by the fame of the then new camp of Tonopah. With a party he walked the 120 miles from Austin to Tonopah in ten days, arriving in the new camp Thanksgiving day, 1901.

From that time he led an honorable public career, being first elected district attorney of Nye county in 1902. Later he served his county as a member of the state assembly to which he was elected in 1918.

In 1920 he became Chairman of the Democratic State Central Committee, and in 1922 was elected to Congress, serving the state and nation in Washington with distinction. Since then he has received honors by being made the leader of his party on various occasions.

Mr. Richards points with pride to his record of fair dealing toward labor and capital during his public career.

Mr. Richards wishes to make it clear that there will be no sectionalism during his administration as governor, but that he will serve all parts of the state without discrimination against any. He expects to lop off tax burdens wherever possible consistent with efficient government.

WILSONS RETURN FROM WASHINGTON

Mr and Mrs Leonard Wilson, who have been residing in Washington, D C., for the past year, arrived Sunday for a month's vacation at home. Both are residents of this city.

Mr. Wilson was for two seasons an officer of the Nevada State Assembly at Carson City and has a wide acquaintanceship throughout the state.

Mr. Wilson states that Washington is a most interesting city in which to reside for a time, but that Las Vegas looks the best to him of any city he has seen.

Berkley Bunker Has Experience

Berkeley L. Bunker, candidate for reelection to the State Assembly, is in a position by reason of his former leadership in that body, to serve his country and state with efficiency and distinction.

In 1936 he received the highest vote of any candidate in Clark county for the assembly.

In the legislative session of 1937 his ability was recognized when he was made a member of some of the most important committees of the assembly. As chairman of the powerful committee on Ways and Means, he occupied what is regarded as the most important post in the legislature, being charged with the duty of keeping appropriations within due bounds. To his tireless work in that position is largely due the fact that Nevada is able today to call itself "One Sound State." He believes in keeping the state free of the so-called nuisance taxes and thereby inviting capital and industry to Nevada.

Mr. Bunker is a native of Clark county, having been born in the now submerged city of St. Thomas and being the ninth child of a pioneer family of ten children. He graduated from Las Vegas high school in 1926 and ever since has been active in the business life of Las Vegas, and now has the Texaco Service Station at the important Fifth and Fremont street corner.

During the last legislature Mr. Bunker was close to Governor Kirman to whom he gave invaluable assistance in guiding the state along safe and sane lines. Among his particular interests was promotion of Clark county highways, specially the Searchlight and Goodsprings roads.

He has resided in Las Vegas since the spring of 1935 and has engaged in the practice of law in Las Vegas since March 1936 immediately after his admission to the bar. He has received evidence of the faith which the attorneys of the state have in him by being appointed a member of the board of examiners of the State Bar Association.

Dashiell Picks New Wolf Pack

Nevada high schools will be represented one hundred percent on the University of Nevada varsity football team this fall, according to a tentative roster compiled this week by head coach Doug Dashiell.

"It would be possible to field two teams made up from men entirely from Nevada schools," Dashiell said. "Some of the spots will no doubt be filled by veterans from last year, and several of them are transfers from other schools," he added.

Very few new transfers from junior colleges or from other four year schools are expected to tryout for the 1938 Wolfpack, according to the coaching staff. About forty men who have had either varsity or freshman experience, for the most part sophomores and juniors will return for the opening of practice the end of this month. Under conference rules, Coach Dashiell will take charge of the workouts Sept. 10, and the Wolfpack will meet the College of Idaho in Reno Sept. 24 for the opener.

One line-up which would include only graduates of Nevada high schools, suggested as a possible Nevada team this fall is Demosthenes (Reno) center; Chessher and Sullivan (both Reno) guards; Spitz (Ely) and Miller (Fallon) tackles; Sala (Ely) and Willard (Fallon) ends; Polish (Yerington) Stewart (Alamo) Cobeaga (Loveland) and Carpenter (Las Vegas) backfield.

A second suggested all-Nevada team might include Beach (Fallon) center; Barsanti (Tonopah) and Dickson (Hawthorne) guards; Giomi (Yerington) and McDonald (Reno) tackles; Hardie (Las Vegas) and Trigero (Reno) ends; Mayer and Paille (both Reno) Taylor (Sparks) and Peccole (Las Vegas) backfield.
