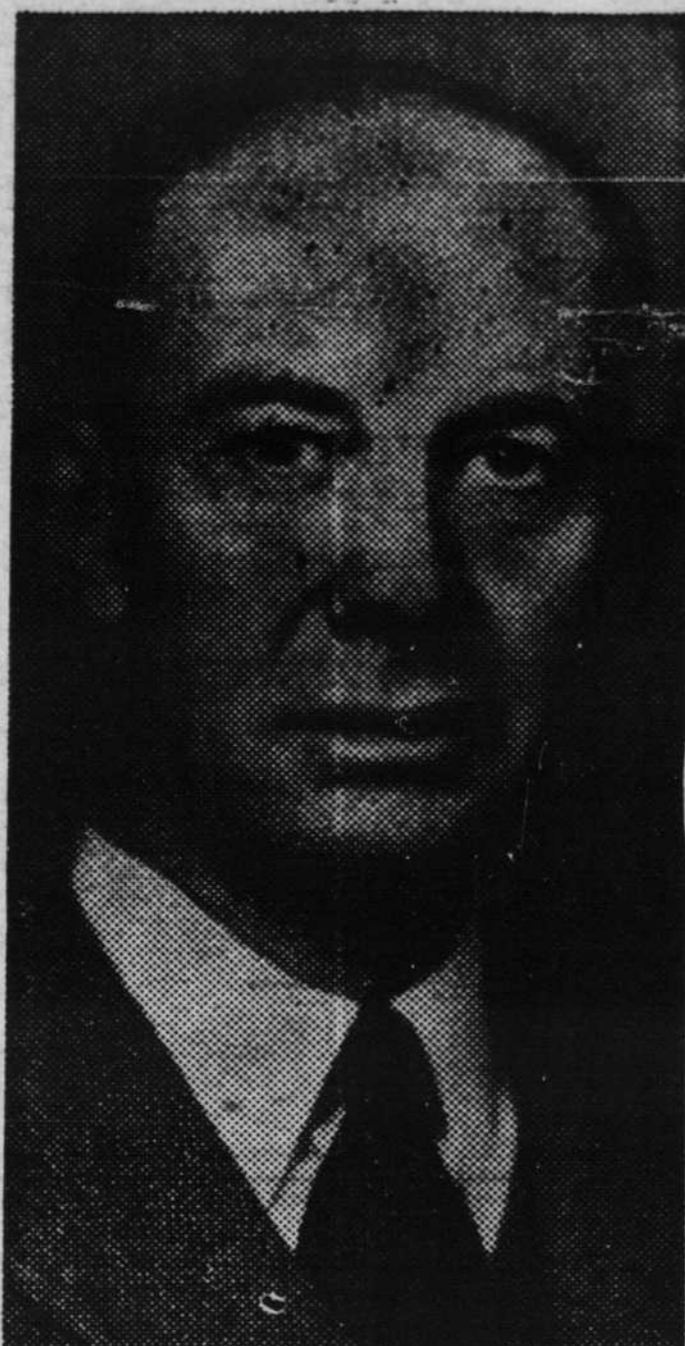


For Governor

To the People of Nevada:

I am submitting my candidacy to you for the governorship of our state.

I am fully aware of the heavy responsibilities attached to that high office, but, as a result of my long residence in Nevada and my familiarity with its problems and industries, I am confident that I can discharge them honestly, capably and with credit to my state.

I was born in Nevada and, with the exception of a few years spent in other fields while engaged in mining operations, I have lived here all my life. I attended its public schools and I am a graduate of its University.

If I should be elected governor I shall be governed by the following policies:

Maintenance of the present simple tax system, long since adopted, under which our industries, workers and homeowners will continue to escape the tremendous exactions of other states.

A progressive state governmental policy, one conducted without waste or the reckless expenditure of public funds.

Liberal legislation to protect all who labor.

Encouragement of the state's great agricultural and livestock industry, of its great mining industry, and every proper protection to its great railway transportation systems, which supply work to many thousands of industrious workmen and which pay a large share of our public taxes.

Continued development and maintenance of the state's highway system.

Application to the various institutions and departments of the state, of the same sound rules of management that prevail in successful private business institutions.

Encouragement of capital to come to Nevada for the development of its natural resources.

Liberal aid to the state's school system.

The people of Nevada have adopted definite policies relating to liquor and gambling and I do not intend to interfere with their judgment in these matters.

I am not and never will be identified with any special group, clique or interest. My sole obligation will be to all of the people of Nevada, and to them alone.
