Barton Held on Murder Charge

Walter Stiles, miner operating in the Searchlight district, died Monday night as the result of a gunshot wound received Sunday during an altercation over the title to mining property near the town. It is alleged by witnesses that the shot was fired by Willett Barton, Searchlight pioneer and former justice of the peace of that township.

According to Fred Colton and Wiliam Douglas, other parties to the dispute, Stiles had nothing whatever to do with the mining claim in question, but was an innocent spectator who was standing near. This statement is concurred in by Mrs. Frances B. Roller, mother of the deceased, and Mrs. William Douglas, mother of William Douglas.

"Douglas and I were doing some assessment work for various parties in Searchlight prior to the passage of the new moratorium act, and had occasion to check up on the records of the district in the recorder's office," Colton said.

"We found no record of any kind on the disputed claim since 1933, and felt we had a legal right to relocate it," Colton said, exhibiting a letter to that effect from the recorder's office.

"Barton disputed that right and we have had several arguments with him about it. Stiles, however, had nothing whatever to do with it. He was just an innocent victim. He and Douglas were together on some other properties, but not this

"Stiles went out with us Sunday morning as a friend, nothing more. He was not down in the hole with us as has been said, but was sitting on top. He was acting as sort of an intermediary between us and Barton.

"I'll admit there was a dispute over the property. All that will come out in the trial. But if there was any claim jumping, Stiles had nothing whatever to do with it," declared Colton.

The property involved in the dispute, Colton said, was called the Ruth Elder by Barton, but they renamed it the Green Quartz, he said.

Stiles was shot through the hips, it is reported, and was rushed to Las Vegas by ambulance for hospitalization shortly after 10 o'clock Sunday morning, when the tragedy. occurred.

Barton stated that he had held his claim for the past 11 years and was doing his assessment work on the property on June 20, when he first ordered the men to leave.

"I fired two shots around in their direction for the purpose of scaring them off Sunday. I didn't intend to hurt anyone, and there was no one in sight at that time.

"Stiles was standing near the hole when I fired the third shot, and the other two men were in the hole, still digging. The shot I fired was not within 10 feet of him, and I was about 300 feet away," Barton said.

Mrs. Douglas said that Stiles was not in Searchlight on June 20.

Both Barton and Stiles were prominent mining men in southern Nevada. Barton is 61 years old and had resided in Searchlight for the past 25 or 30 years.


"If general opinion here," added, "and this, it seems, will be the case, favors the construction of the building, work on it will begin in the spring."

The prelate emphasized that space in the proposed edifice will not be restricted to Catholics, but wil be available to anyone.


