Nevada Wlofpack Scott Murder Starts Its Season Trial Concluded

UNIVERSITY OF NEVADA, Reno -The University of Nevada Wolfpack went into its final sessions of work this week in preparation for the coming season. Nevada opens in Reno against the College of Idaho, September 24, and the following weekend will go to Las Vegas, Nevada, where that city will be host to Arizona State and the Pack. This will be the first time two college football teams have met in that section.

The University of Nevada squad, under the guidance of head coach Doug Dashiell and his assistants, Duane Keller, Che Scranton and Pat Eaton, has come along to a fine point, and for a team that won only two games last season, greater spirit has been manifest than in years of Wolf Pack history, according to "those in the know."

The Wolves' schedule, which on the surface appears not too tough, is no set-up. Arizona State always has a big strong team; Colorado State at Greely is good enough to rate in the top bracket of the Rocky Mountain conference, and were co-champions only a couple of years back, sharing the honor with the University of Colorado, home of "Whizzer' White. Of the Far Western conference opponents, only Chico was not too tough for the Pack last year. In addition there are two known strong clubs from the coast to beat, San Francisco State and San Diego State. It might be added that Coach Dashiell is not taking the Idaho gang lightly, judging from the workouts he has put the Pack through.

Two old men, will make up the veterans of the squad. Harry "Pop" Bradley, who is the last four-letter man in the conference, will be in one of the tackle spots. Neal "Pee Wee" Campbell, the other vet will work at both right and left ends.

Besides these two, there are ten letter men with one year of varsity experience. The thirty-four other good prospects have experience ranging from junior college to freshman.

While this seems to be a purely green squad, Dashiell can put a well-balanced team on the field. The strating line-up cannot be predicted so early, but at ends may be Galloway, Sala, Campbell, Clayton, Carpenter, Trigero, or Willard, all lettermen but the last two. At the tackle posts Bradley Spitz, Kievitt, Bryant, Collier and Giomi have been showing up well. The guard positions, with Robinette and Brooks, when Tapia is at center; and with Lee Barsanti, Dickson, McDonald, and Chessher to work in, will be well taken care of.

The trial of Edward Scott for the alleged shooting of Larry Saundders, last June has occupied the attnetion of the court the past week. Scott, who is a world war veteran. was charged with fist degree murder. The trouble arose ocer an argument over the world war. Saun ders was asked to leave. When he refused to go Scott left and went to live with P. Body in the living quarters of his store in North Las Vegas. Saunders later went to the store and revived the argument which ended in a scuffle and the firing of the shot which killed Saunders.

Roland Wiley and C. A. Jones appeared for the defendant while District Attorney Roger Foley and A. S. Henderson are prosecuting the case. The jury was completed Monday afternoon and is made up of the following men:

Judge Wm. E. Orr will render judgment at 9:30 Monday morning.
