with the greatest benefit to the people of the state

Labor and Industry

"The relationship of labor and industry is a very important question requiring very careful study so that the interest of the people of the state shall be protected to the fullest possible extent, at the same time recognizing the fact to proper returns for the services they perform

"The transportation interests of the state pay a great portion of the taxes in direct and indirect forms. The railroad lines and the truck lines should be regulated so that they will both serve the people of the state to the best advantage and at the same time be able to earn profits within reasonable limits. If transportation interests cannot operate at a profit they must either go out of business as many of our short railroad lines have had to do, or possibly be taken over by the federal government and in either case the state will lose the taxes. The taxes which these facilities will have been paying will then have to be made up in other ways, so that the burden of taxation upon the people of the state will inevitably be heavier.

Public Utilities

"The public utilities are subject to state regulation and here again we have substantial amounts paid for taxes. The regulations should be such that the greatest service to the people at a reasonable cost can be rendered while, at the same time, the utilities are entitled to a reasonable return from the business.

"In the matter of old age pensions and relief, a careful study must be made to insure the proper provisions for both, at the same time recognizing the fact that the

PROVO, Utah — Students from practically every city and town of the intermountain area will be turning their steps toward Brigham Young University here when it opens its 63rd year this month.

Autumn quarter registration has been set for September 23, 24, and 26, and regular classwork will begin on the 27th, according to university officials. New students will be entertained by the student body officers in a special series of "get-acquainted" programs and dances, it is planned.

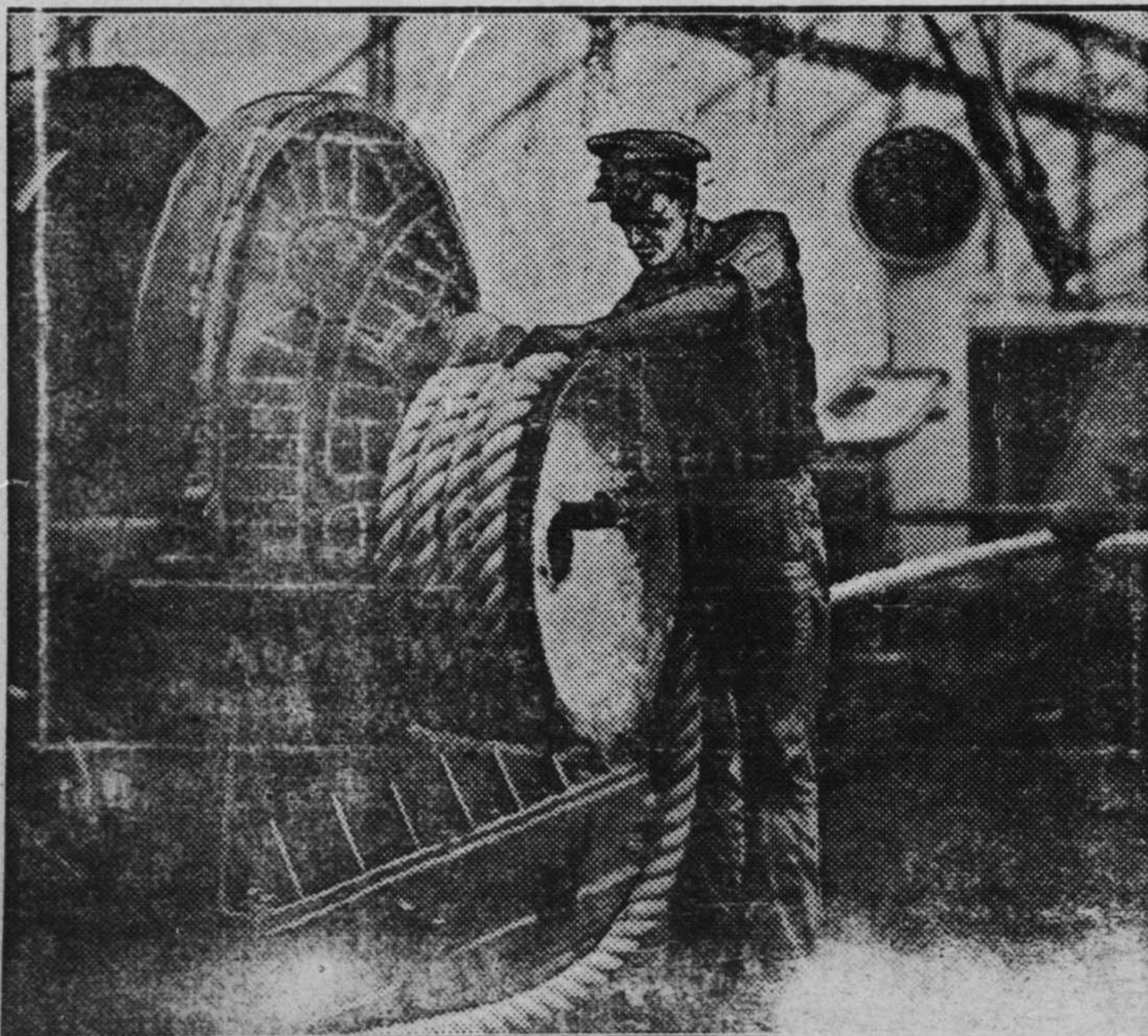
