City Welcomes Universities Of Arizona And Nevada Today For Game On Butcher Field

"At full strength" said a pesimisthe Douglas Dean Dashiell, "we would beat the Arizona State Teachers, and we may even do it in the condition we are in, but we will know definitely tomorrow afternoon when the last whistle blows."

And this Douglas Dean and his pessimism is not a new thing to he sport loving Las Vegans, in the throes of promoting their first intercollegiate football game, as it was in this southern metropolis where the tall drawling Texan got his first taste of football fame as he "champ maker' with four consecutive Nevada high school football crowns.

Beset with early season injuries two collegiate teams, he throws only a portion of his Wolfpack into the breach to stem the tide of whaking Arizona Lumberjacks.

In the strategic quarterback position the "champ maker" will call upon stocky, little Frank Beloso, of Reno, who has been developing rapidly, because injuries have placed three of his quarterbacks on the bench. Walter Powers, the Sparks flyer and speed merchant of the team, is forced to be played but lightly due to injuries to his ankle. Power teamed with Yerington's all-state John Polish at left from his all-state end position. half formed one of the most dangerous combinations in Nevada football history, with Polish doing the heavy work to the strong side of the line, and Powers using his speed through the weak side. But that combination will see little if any service tomorrow because of the injuries to Powers. Polish too, is suffering from an ankle injury which has slowed him down considerably. Also missing from service in this position is Chuck Whitham who was injured in the fifth play of the College of Idaho game a week ago and will not see service for the rest of the year.

Ready to back Polish at a moments notice will be Mitch Cobeaga, willowy left half, who has shown promise during the early season game with College of Idaho. Cobeaga passing his bullet shots will form an intricate part of the Dashiell razzle dazzle when it gets going at full blast early in November. The lacks experience. vaunted, " now you see it, now you don't" will be forsaken for this Arizona game with the Pack relying on straight football. As the "Dean" puts it, "I wish the game
