Season tickets will be soon on sale. One of the features of this year's meet will be the season tickets to the grandstand for the four days of racing at a price of \$3.30. There will be no reserved seats. Student's season tickets will be sold for \$1,65.. Daily admission will be \$1.10 for adults and 55c for children.

Eight of Las Vegas' most beautiful girls have already advised the ticket committee that they will vie for high honors in the ticket sale, with first prize for the most tickets sold an all expense ari trip to the Rose Bowl New Year's football game. Second prize, an air trip to San Fransisco.

Various Las Vegas merchants and business men are sponsoring races each day by posting an added purse. Those so far are; Sal Sagev Hotel, Von Tobel Lumber Company, Tivoli Tavern, Ernie Cragin and the Caca Cola Bottling Co.

# Be Galla Affair Regular Meeting

Tuesday's meeting of the Las Vegas Chamber of Commerce in the Marine room of the Apache Hotel brought out many things of interest to the people of Clark county.

Of most interest to Clark county was the statement of Mr. W. H. Crozier, engineer, to the effect that the power line from the dam to the mining community of Goodsprings "seemed to be an asured fact." Mr. Crozier made it clear that nothing was definited upon the construction of the line as yet, but that it had been reported over the radio that the government had set aside the sum of \$282,519.00 for the proposed construction.

Mr. Crozier, as well as Mr. De-Armon, chairman of the Colorado River commission of Nevada were present at the meeting. The discussion of the Goodsprings power line came about when J. W. Squires requested that the Chamber of Commerce aid the community of Goodsprings in any manner possible to secure the power line and requested that Crozier or DeArmand advise in what manner aid might be given. Crozier, in closing stated that it would be well for the Chamber of Commerce as well as individuals to wire their representatives in behalf of the project.

C. D. Baker gave an interesting talk on the recent trip of himself and President Robert Griffith to the 4 state highway conference at Twin Falls, Idaho. Baker stated that it was now possible to travel from Las Vegas the entire distance to the great winter playground of Sun Valley, Idaho, on paved highways.

Baker also stated that the 1940 convention of the 4 state highway conference would be held in Las Vegas.

Bob Kaltenborn reported that the Junior Chamber of Commerce had taken over the task of making the scheduled winter race meet a success. The ocmmittee has set the week end dates of November 26 and 27 and December 3 and 4 for the meet.
