thereof not to exceed the sum of one thousand dollars. And any in-cidental costs for succeeding fiscal years shall be paid from the annual bounty appropriations, the same not to exceed the sum of one hundred dollars per fiscal year. SECTION 5. For each fiscal year

while this act shall be in effect, for the payment of bounties as provided in section 1 of this act, and other costs as provided in section 4 of this act, there is hereby appro-priated from the general fund in the state reasury, of moneys not otherwise appropriated, the sum of twenty-five thousand (\$25,000) dol-lars, and any residue of said sum remaining unexpended at the end of any fiscal year shall revert to the general fund in the state treas-

SECTION 6. The State of Nevada shall enter into no agreement to cooperate with the federal govern-ment for the destruction and eradication of predatory animals, where salaries instead of bounties are paid, but may enter into such an agree-ment if the federal government shall accept the bounty system as hereinabove ou lined and enacted, provided, that in case of such agreement the federal government's share of the cost shall equal or exceed that of the state, and the bounties shall be no less than hereinabove provided.

In the event of such an agreement no trophy less than the whole skin in proof of a claim for bounty, as provided in section 2 of this act, shall be accepted, and each skin shall be perforated or branded, as hereinabove provided, with the let-tering and words "Bounty Paid— Nevada."

And it is hereby further provided that no American citizen shall be denied the right to participate in the earning and collecting of such

SECTION 7. Any previous act of the legislature pertaining to the destruction and eradication of predatory animals, or the trapping thereof, and that certain initiative law or act of the people adopted at the general election of November 6. 1934, entitled "An act providing for the payment of bounties for the destruction and eradication of predatory animals, prescribing the manner of payment, providing for co-operation with the federal govern-ment in such eradication by bounty payments, other matters relating thereto, and repealing all acts and parts of acts in conflict herewith. are hereby repealed.—be approved?
