THE SCHOOL QUESTION

At the regular Tuesday meeting of the Chamber of Commerce the "MYSTERY OF THE ELIMINATION OF THE TWO MILL STATE SCHOOL TAX" was discussed.

Why all the secrecy by the state school lobby on initiative petition No. 1 that will appear on the ballot next Tuesday? Why not tell the people of the state what the masure REALLY MEANS?

A member of the Las Vegas school board stated at the Las Vegas Chamber of Commerce meeting that "the removal of the two mill state school tax WOULD NOT INCREASE TAXATION." The school official who made that statement knows well that the schools are trying to get MORE MONEY TO SPEND, and that more money for the schools means MORE TAXATION. What is this two mill state school tax?" IT IS TWENTY CENTS TAXATION ON EVERY HUNDRED DOLLAR VALUATION. The "two mill" wording is simply a blind for the taxpayers—whom the school boards of the state seem to think of as being only a bunch of first grade pupils.

WE WILL GIVE YOU HERE THE TRUTH of this taxation qpestion. It is a vital question to EVERY TAXPAYER IN THIS STATE.

Should this measure pass on November 8th, and the the government needs the money, and so-. schools decide to increase this "TWO MILL" tax to four mills, which they can do — WITHOUT ANY POSSIBLE RECOURSE FROM THE PEOPLE WHO PAY THE TAXES, here is what we would face.

Immediately the general county tax rate would be reduced from \$1.60 to \$1.475. The City of Las Vegas rate would be reduced from \$1.17 to \$1.045. This would be necessary if the \$5.00 constitutional tax limit was not raised. The only other measure that could be resorted to would be that the assessor of Clark County RAISE THE ASSESSED VALUATION OF EVERY PIECE OF PROPERTY.

WHEN THE COUNTY OR STATE SPENDS MONEY, THE TAXPAYER MUST FOOT THE BILL.

What do the Clark County schools pay for their maintenance and operation today? We will give you herewith THE OFFICIAL FIGURES OF THE STATE OF NEVADA.

Our schools spend, every year, 47 per cent of every dollar that the taxpayers dig up.

While the school lobby is giving the taxpayers the sob story for MORE money to spend, here IS ACTUALLY THE CONDITION OF THE SCHOOL FINANCIAL SITUATION:

The State School and University fund had on hand, June 30th, 1938, in BONDS THAT HAD BEEN LOANED TO OTHER STATES AND STATE INSTITUTIONS the grand total of \$3,148,000.00 of the taxpayers' hard earned dollars. THIS IS NOT ALL. They also had, IN CASH, \$352,578.00. AND OUR POOR SCHOOL OFFICIALS WANT MORE MONEY TO SPEND.

If any school in the state IS HONESTLY IN NEED OF ADDITIONAL FUNDS, our statute provides for that emergency. It is not necessary for the people of this state to grant ANY few people the right to tax the property owners of county commissioners are dishonest. in any sum they might wish.

The Clark County school system is the HIGHEST IN-DEBTED COUNTY IN THE STATE per hundred dollar valuation. Washoe County (Reno) has an assessed valuation of that make the so called taxpayers' league the laughing stock

\$43,000.000.00 and has a total debt of \$971,550.00. Clark County debt ALL BUT \$39,000.00 is owed by the schools. In addition to this Washoe school funds were, on the 30th day of June, 1938, \$572,000.00. Those of Clrak County-money in the bank—amounted to the grand total of \$189,000.00.

AND OUR SCHOOLS NEED MORE MONEY. What the schools REALLY NEED, is a little spirit of economy - and NOT OF SPENDING.

In addition to the regular tax funds the schools of this state receive— they get 65 per cent or 95 per cent of the \$200,000.00 state liquor tax.

It might be a good idea to turn the operation of the schools over to the board of county commissioners, or at least give them control of expenditures of the taxpayers money — they don't have any control now.

VOTE NO, taxpayers, on proposition No. 1 next Tuesday. WE WANT good schools — and have gone far enough until we can pick the old dollar bills off the sage bushes and mesquite trees.

IT'S IN THE AIR

WHY?

Why has the "Taxpayers' League" almost faded into the past — when it should have been one of the outstanding organizations of the city? The answer is simple. Its failure to accomplish anything is due primarialy to ignorance of the problems that they were supposed to remedy.

For example - one man made the statement that the county commissioners had accounted for only \$92 of each \$100 collected in tax money. I can't believe that Treasurer Bill Mundy nor Auditor Dave Farnsworth do not know what the county commissioners do with the money of the county. Neither wo I believe - nor do 95 percent of the taxpayers of this county believe that the members of the present board

I firmly believe that either board of commissioners (city or county) would welcome ANY CONSTRUCTIVE CRITICISM.

It is foolish statements such as were made last night
