AGAIN, THE RECALL?

Again Las Vegas is faced with the destructive threat of a recall election directed against Mayor H. P. Marble. The movement is based, apparently, on a difference in policies, the principal point being the recently enacted license ordinance.

The public easily forgets the fact that the Mayor and the City Board are under attack from both ways practically all the time. On the one hand every day all members of the board are under pressure from individuals or groups who want additional streets paved, sidewalks built, street lights intalled, police protection extended or additional fire fighting equipment, and such groups attend meetings of the board and try to force their demands by political pressure, arguments and sometimes by threats.

On the other side of such questions are groups of taxpayers or businessmen who demand retrenchment in expenditures and various reductions in city expenditures. The Mayor and City Commissioners are giving their time and efforts in the effort to do what is best for the majority of the people. They should receive the advice and sympathetic coperation of the public and will be found to be readily responsive to the wishes of the majority.

And, in view of the fact that the regular city election is but a few months away, it seems folly to put the city to the expense of several thousand dollars when, even if successful, the recall will accomplish no beneficial results whatever.

This recall movement can accomplish little or nothing beyond stirring up local hatreds and advertising to the world that Las Vegas is a poor place in which to live.
