RACE MEET OUR BUSINESS

Las Vegas people should not consider the annual race meet now under way as a matter pertaining exclusively to visitors who may be attracted to the city. On the contrary, it is one of our greatest potential business interests and will, if properly encouraged, develop into one of the outstanding attractions of the Southwest.

Every businessman and every employe should consider the development of racing in Las Vegas as a major attraction for his particular business. They must show their loyalty by the encouragement and particularly by their attendance, without which the business cannot be successful. Whether the annual racing meets shall be continued in the future depends largely on the manner in which the present session is supported by local people.

OUR COUNTY HOSPITAL

We are reliably informed that the board of county commissioners contemplate the expenditure of several thousands of dollars of the taxpayers' money for more equipment at the county hospital. We wonder if such an expenditure would be a wise move.

It is our wish, as we have stated many times, that every person in Clark county should receive EVERY MEDICAL CARE POSSIBLE WHEN SICKNESS STRIKES. Whether he be rich or poor, he should be given the finest of care. Poverty is no crime. Yet it is a crime for any person NOT TO RECEIVE THE BEST OF MEDICAL AID when needed.

Let's take a look at what'we get - for the money we expend for those we call indigents — those who may be less fortunate than their neighbors.

Clark county spends each year for the county hospital almost \$20,000 — to be exact, \$19,879.59 during the past fiscal year. This amounts to exactly an average of \$1,656.63 per month. This expenditure does not include the large amount of money already paid for the county hospital plant.

We do not believe that Clark county should go into the hospital business, especially so when FOR LESS MONEY THAN WE EXPEND TODAY, EVERY PERSON COULD RE-CEIVE THE FINEST OF HOSPITALIZATION.

It would be the height of folly for the county to attempt to equal the plant of the Las Vegas Hospital association, who have installed over \$50,000 in latest medical instruments.

Why not let our county patients have the advantage of have incurred Presidential displeasure. this great hospital — and at the same time SAVE THE TAX-PAYERS MANY THOUSANDS OF DOLLARS A YEAR?

It certainly is no time for the county commissioners to turn doctors - and spend thousands of dollars more on the county poor farm.

Borrowed money must be paid back - as well as also paying for the bonds. The words of the county superintendent of schools are still ringing in our ears: "The removal of the two-mill limit state tax for schools WILL NOT INCREASE OUR TAX." We are patiently waiting for the sad news that "Due to an emergency, etc., etc., etc., the state rate has been increased to six mills."
