As is usual, the local P.-T. A. has a long list of good deeds to its credit for the past year.

Undernourished children claimed the attention of the organization, and 108 of these little unfortunates were served hot lunches. Organizations which contributed funds to make these hot lunches possible were: Elks lodge, which gave \$25; Modern Woodmen, \$15; and the Ladies' Aid of the M. E. church, \$5.

The distribution of clothing is another project undertaken by the organization. This work is carried on in a room in the high school building, with groups of women from various organizations in charge. For the first two weeks in December the work is under the direction of Mrs. William Mendelsohn and a group from the Hebrew Circle.

At a recent meeting of the executive board of the organization one \$5 tuberculosis bond was purchased and \$5 contributed toward the White Christmas.

Thieves Loot **Davison Home**

While Mr. and Mrs. Earl Davison were in the East, their house in the southern part of town was robbed of valuable belongings. Entrance was gained through a rear window by breaking the glass.

The theft was discovered by little Ruth Ann Van Meter, who, while playing, noticed the front door of the Davison house was open, and the police were notified.

Doctors Speak On Tuberculosis

Thursday evening two doctors prominent in public health work spoke before a P.-T. A. meeting in the grammar school building, to which the public had been invited to attend.

Dr. Fred T. Ford, regional consultant for the 11 western states in the United States public health service, and Dr. John Norton, of the Nevada state board of health, spoke on the control of tuberculosis in Nevada. Their talks were illustrated by motion pictures and slides. Hear Views On Over In Vegas Museum Problem

Assemblymen - Elect Tom Carroll, Berkeley Bunker, Hap Hazard and Rev. C. H. Sloan met Tuesday evening at Tom Carroll's office to discuss with the Chamber of Commerce ommittee headed by K. O. Knudson the question of control and naintenance of the Overton museum. O hers present at the meeting were James H. Down, Mrs. Gamble, Dr. William S. Park, Al Cahlan, and C. P. Squires.

During the discussion it developed that fear has been expressed by some of the people of Moapa Valley that the museum of archaeological relics established near Overton several years ago might lose some of its exhibits by their removal to the museum being established by the National Park service at Boulder City.

It was brought out that there is a vast area of prehistoric ruins in both the Moapa and the Virgin valleys which may be excavated and which will yield a large quantity of valuable museum exhibits and that there is no need for removal of any exhibits from the Overton museum.

As the outcome of he discussion K. O. Knudson and his committee were requested to interview Supt. Guy Edwards of the National Park service regarding the matter.

City Meeting **Hears Charges**

The meeting of the city commission called for last night got under way promptly at 7 o'clock as scheduled, but due to the large crowd present to hear the charges against two Las Vegas liquor stores, the meeting was transferred to the district court room in the courthouse.

Charges had been made by John Cahlan, juvenile officer, that two liquor stores had sold minors intoxicating liquors. The stores charged by Cah'an were the Exchange bar and Rose's Liquor store. Ethel's Liquor stores were mentioned in the supposed confession of one of the youths, presented to the city board by Cahlan, but upon examination it was found that no purchases had been made from these stores, so Mrs. Rapaport, owner, was excused by the mayor.

In opening the meeting, Mayor Marble made it plain to those prosent that the meeting was in no sense a trial - that the commis-
