Zora Folley, coming off of his one-handed victory over Canadian Strong Man, George Chuvala last Friday at Cleveland, has re-entered his candidacy for a shot at Liston's title. Folley, Arizona fighterpolitician, put on one of his trademarks, over-cautious fights. He used a jarring left jab almost exclusively, even though most of the night Chuvala was inviting right hand shots to his jaw, by keeping his left hand so low, that he appeared to be trying to catch Zora by the ankle.

There is no question that Folley has an excellent right which is capable of decking any heavyweight, including Chuvala, who has never been put on the canvas in his whole career. Zora, refusing to risk a right hand lead to the Canadian's unprotected chin, might just as well have left his right hand back in Chandler, Arizona, except that it served him as something of a catcher's mitt in protecting his head from George's lethal hooks from out of left field. Folley was just too timid to risk catching one of Chuvala's lefts, so he held his right hand close to his vulnerable chin for the entire ten rounds, excepting those few times when he let it fly automatically as a counter punch.

Chuvala was able, at times, to force through Folley's guard, and drive the Arizonian into the ropes, where he had his best success of the evening in close. Chuvala was also able to stick Zora with his left jab

on those few occasions that he tried. The whole story of that fight was Zora Folley stick-ing Chuvala with a sharp left jabwhich carried enough power to keep Chuvala from getting set for his bull-like rushing attacks. I am certain that Folley is not foolhardy enough to think that such a plan of attack would be successful against Sonny "The Bear", Liston, The Bear has the very best, as well as most damaging, left jab in the business. He has that same secret weapon, that belied make The Brown Bomber so ominous in the squared circle.

Folley has had one encounter with the present King of the ring. In that fight, in the third round, they brought Zora's stool out of his corner to him, after hams, which hang at the ends of his gorilla arms. where hands are supposed to be located

If Zora could not avoid Chuvala's left jab, he would find his head in the lap of a ringsider seated in the tenth or eleventh row after catching one of Sonny's jabs. If Zora could not defend against some of the rushes that George Chuvala made, he would fare much better in holding off a General Sherman Tank, than he would in defending against Lethal Liston when he

Sonny Liston finds himself in the position of a King with no subjects to rule. The Champion has no logical opponents to challenge his rule. Liston could possibly do something about this situation if he would sign to fight the top two heavyweights on the same card. It would, however, be more of an even match if he would face the two of them at the same time,
