Nevada Equal Rights Commission in Hawthorne

the feeling in walking into the Mineral County courthouse, place of the recent hearing of the NERC; (Nevada Equal Rights Commission) of being in the old west — the courtroom in which the hearing took place could very easily be a motion nicture. picture set in a replicia of the early 19th century roaring west. In these antiquated surroundings, filled with local businessmen, county commissioners and other public officials, one felt that it was a Hollywood set for a western movie.

Chairman of the Commission, Bob Bailey, handled the swearing in of witnesses, and the most of the interrogation. It was brought out that the discriminatory practices of the majority of the businessmen there did not necessarily represent the feeling of the white community. However, there is a fear that is detected in this town. The Smith Brothers, with their segregated policy at the El Capitan Hotel, have set the general discriminatory pattern for other places of public accommodations. Until the Smith Brothers change, are brought into line with democratic principles of freedom and equality for all citizens, Hawthorne will continue to bring shame to Nevada,

The feeling one gets, while listening to the testi-mony of various local officials, brings back the story of how the dominated people of Europe must have felt during the rein of Hitler. It is quite feasible that the Negro of Hawthorne because of local discriminatory practices, could be brainwashed into a frightened state of acceptability to second class position. However, it becomes a very serious situation when the Caucasian, in a white man's world, accepts a second class position for fear of economic reprisals. Such an atmosphere gives one the feeling that the democratic structure, under which this republic was founded, is being threatened.

The Equal Rights Commission made strong suggestions that a Human Relations Committee be established whereby all racial, ethics and religious groups could start working out a program by which a better understanding of problems peculiar to each group, could be realized. Knowing this will not be the only solution towards full class citizenship for all in Hawthorne, but believing that this can in fact become a starting point to the breakdown of antiquated, discriminatory practices, it will be a beginning in the right direction.

During the interrogation of the witnesses sub-poenced, one could glance in the audience and see evidence that the average white person and Negro in the audience felt a certain kinship as opposed to the scene one would expect from the evident atmosphere of segregation which exists in Hawthorne. One begins to get the feeling that the problem of Hawthorne proper is not as challenging as the appearances of the situation would indicate. One also gets the feeling that once dictator Smith, and blind hatred of equality for all, has been destroyed, the Negroes and whites of this little town in Nevada could emerge as peaceful and democratic as any town in Nevada could expect. There is a responsibility in Hawthorne, that the Negro himself must tak. Commissions and pressures from without can only serve to implement their efforts, but until they themselves stand up and demand an equal position in their community, all outside efforts will be to little avail.

The thinking of most of the businessmen and elected officials is that they are not going to put themselves out on that proverbial limb, until the Negroes themselves have shown the same zest that other noncaucasians thruout the world have shown and are showing in their quest for full equality.

It leads one to wonder how the town of Hawthorne has been allowed to maintian its old patterns while the rest of the state is striving to correct the old dixie system of a democratic society.

In the final analysis, Hawthorne, still is a city of fear on the part of both white and colored. Until Hawthorne falls in line with the progress being made in this state, in the field of Civil Rights, Nevada shall continue to reflect a poor national image. We shall continue to be embarrassed by the incidents of discrimination that Hawthorne practices. Until all people of this state, both whites and colored, stand up to the Lindsey Smiths of Hawthorne, the Jack Streeters of Reno, the Abe Millers of Las Vegas, and demand compliance with the principle of equality for all, Nevada will be counted with the Alabamas, the Louisianas, the Georgias and the Mississippis as castigators of America's character.

have criminal records -- that certainly would not be accepted in "our society." This statement, though carefully planned and prepared, reflects your background of a dual society. It is your heritage to think in terms of a White Society and a Black Society. Such thinking is the most subversive thinking that can happen in a democratic society, and you had the audacity to refer to us as subversive.
