

**MRS. NELSON SAYS  
'I WILL BE THERE'**

SPARKS- Mrs. Esterline Nelson of Sun Valley, Nev., says she "definitely" will appear at the next meeting of the Nevada Legislative Commission to press her complaint that she was discriminated against by the manager of the commission's Counsel Bureau because she is a Negro.

Mrs. Nelson, an employee of the Counsel Bureau for two and one-half years before her recent resignation, claims she was forced to quit her job "because of the persistent unpleasant and unfair treatment" she experienced while under the supervision of Amos Buckner, who manages the bureau's printing office.

Emphasizing that she was not seeking reemployment by the bureau, Mrs. Nelson listed her grievances against Buckner in letters to all eight members of the Legislative Commission. At a meeting on March 13, the Commission invited Mrs. Nelson to appear at its next meeting, scheduled for the latter part of April.

"I DEFINITELY will attend the April meeting," Mrs. Nelson said, indicating that she would repeat her complaints against Buckner orally.

Although Buckner has declined to comment on Mrs. Nelson's charges, another member of the Counsel Bureau staff has substantiated her claims that Buckner "picked on" her.

Mrs. Doris Pears, a five-year employee of the Counsel Bureau, said Buckner "shoved" Mrs. Nelson and herself into a "cubbyhole" and "told us to just sit."

Russell McDonald, director of the bureau, said he and other members of the staff had tried to persuade Mrs. Nelson not to resign.
