Good laws are not enough to combat the degenerating moral effects of discrimination," Cardinal Cushing said in a Pentecost Sunday message, because if they were, Massachusetts "would be a place of perfect brotherhood."

In spite of good state laws, he said, "I am forced to record that conditions in Massachusetts remain very far from ideal. Our Negro population is largely confined to ghetto areas.

"This is why . call this city and its citizens to justice. . . call them to change their hearts and raise their hands before the

evils that we are tolerating call down the wrath of God upon His forgetful people . . . and I ask each person to do his duty.'
