NEGRO LEADERS HA L NEW FINANCE PLAN

K SPOT BOMBING

LOCAL LAW ENFORCEMENT authorities, shocked by the first act of violence ever reported here in connection with the purchase by Negroes of a home in a previously all-white neigh-borhood, have pledged "all-out" prosecution of anyone found to be connected with such despicable acts.

Target of the locally unprecedented act of intimidation were Mr. and Mrs. Stanley Morgan and their eight-year-old son, Sonny. The Morgans moved into a \$24,000 house at 113 Shadow Lane in the Rancho Manor section three weeks ago. Last Sunday night at 10:15 p.m., an undetermined explosive blasted a hole measuring one foot by 10 inches through the nine-inch concrete block wall at the rear of the property. (See photo.)

Mrs. Harriet Morgan and young Sonny were in the house at the time. The elder Morgan was at the Hacienda Hotel, where he has been per-

forming with the Ink Spots vocal group.

Mrs. Morgan rushed out of the house at the sound of the explosion, which was heard by Las Vegas police detectives at their downtown headquarters more than a mile away, not realizing that the blast had occurred on her own grounds. She soon realized the true situation when neighbors poured out of other new homes along Shadow Lane and converged on the Morgan residence. The hole in the wall was discovered a few minutes later.

A half dozen detectives were on the scene within ten minutes and began an immediate investigation. Det. Lieut. B.J. Handlon said the blast apparently was caused by a small charge of dynamite "and someone definitely put it

WASHINGTON--Revelations that will surprise many people--particularly realtors and lending institutions—recently came out of a survey in Montgomery County, Md., the wealth-iest and most exclusive of Washington's white suburbs.

ed residents of this sw Ine were asked if they were ready to accept Negroes as neighbors. Posing the question in a diligent doorbell ringing campaign was an organization called Suburban Maryland Fair Housing, an interfaith group strongly backed by the churches and synagogues of Montgomery County and headed by a Presbyterian minister.

During the past few weeks, SMFH canvassers have called at 40,000 homes in Bethesda, Chevy Chase, Kenwood, Potomac, Silver Spring, and other Montgomery county suburbs. They found about 70 per cent of the families at home on the

From the 28,000 homes contacted, the canvassers obtained approximately 15,000 signatures on "fair housing" pledge cards.
