ANOTHER PROMINENT boxing figure from the Southland who feels Las Vegas has great promise as a club fight center is Pinky George, now back in harness after almost two years of inactivity due to heart sickness over the unfortunate brain injury sustained by his fine Argentine heavyweight, Alejandro Lavorante, in his 1962 fight with Johnny Riggins.

Pinky has finally become reconciled to Alex's untimely demise and is now handling several good boys who have appeared here, including high-ranking welterweight Curtis Cokes and undefeated bantam Norman Parra.

Parra's sensational knockout victory over rugged Willie Kee, the Navajo Indian scrapper from up Reno way, earlier this month at the Castaways proved that his two previous victories over otherwise unbeaten Lenny Brice were no flukes. Norman should go a long way under the able guidance of the astute Pinky.

Miller is providing local battlers with a great chance to show their stuff and most of the boys have been rewarding him with fine per-
