Investigation, was informed of the incident and made inquiries "as a matter of course." Elson said the FBI had been asked by Chief Peterson to locate and interview a possible "witness" to the incident who allegedly had left the state. Elson further stated that he had made a preliminary report on the matter to the Department of Justice in Washington, D.C.

A.B. West, regional director of the Bureau of Reclamation, also became concerned about the situation in view of Lockette's employment by the bureau, and made his own report to the Department of the Interior in Washington.

IN THE MEANTIME, Allen Reeves, editor of a Boulder City weekly, became interested in the case when he was issued a "one paragraph press release" from the Boulder City police department relating that "a beer bottle had been tossed on the sidewalk" adjacent to the Lockette address, with the comment that the incident "apparently was a juvenile prank."

Reeves said he became curious as to why a press release would be issued on such a normally unimportant incident and decided to probe into the matter. Upon discovering the identities of the suspects and the deeper implications of the incident, Reeves said he decided to reveal all the details in his Boulder City paper.

However, Reeves said that in the absence of the publisher, an executive in charge refused to use his account of the incident and gave him the choice of "watering down" the story with the names of the suspects deleted or resigning. Reeves decided to resign and is now employed in a different field.

The executive who allegedly delivered the ultimatum to Reeves has disputed the ex-editor's version of his separation from the paper, claiming that Reeves had "blown the story up out of all proportion."

In rebuttal, Reeves inferred that the parents of the suspects "and others" had exerted pressure on the paper to keep the names of the suspects out of print under threat of economic reprisal. Reeves said one or more of the suspects had minor police records, an allegation later verified by Chief Peterson.
