

SOUTHERN NEVADA BODY TO REVIEW CIVIL COMPLAINTS

CIVIL RIGHTS COMPLAINTS originating in this area will be reviewed by the Southern Nevada Human Rights Commission prior to being heard by the United States Department of Justice under provisions of the Federal Civil Rights Act of 1964 according to commission chairman M. William Deutsch.

Deutsch said that the services of the commission, which was legislated into existence by the City of Las Vegas and Clark County, are available to anyone having a civil rights complaint. Commission headquarters are located at 830-C West Bonanza Road, telephone 384-5721. Explaining that cases are investigated promptly and acted upon swiftly, Deutsch said, "Members of the commission are not anticipa-

Explaining that cases, are investigated promptly and acted upon swiftly, Deutsch said, "Members of the commission are not anticipating a rash of such complaints in the Southern Nevada area since racial relations here are constantly under study in an effort to improve conditions."

Deutsch pointed out that the Southern Nevada Human Rights Commission has been operating "discreetly" since June 15, 1960. He said charges of racial discrimination, including refusal of service in public eating places and denial of accommodations at hotels or motels, had been investigated by the commission long

The chairman further explained that designation of the commission as a preliminary hearing board on civil rights complaints before they were submitted to the Attorney General was in accord with the Justice Department's policy of keeping enforcement of the new Civil Rights Law on the local level until a definite pattern of non-compliance by local law enforcement authorities was established.
