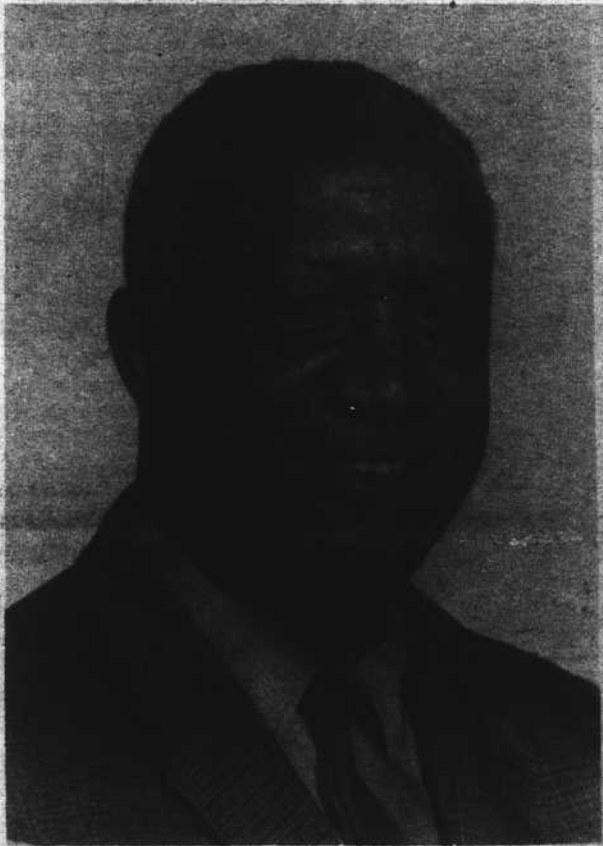

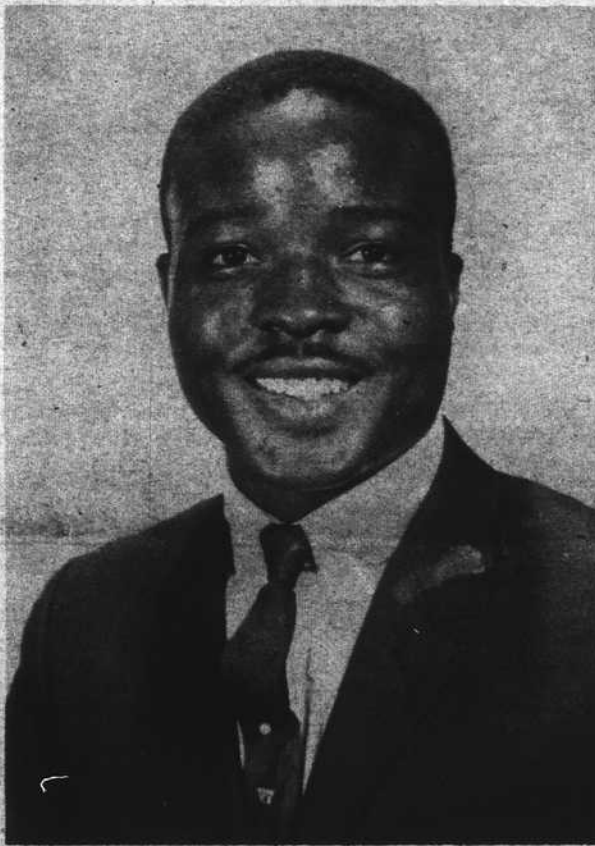

PRESIDENT CLAIMS STATE APPROVAL FOR MARK TWAIN

THE INSURANCE DEPARTMENT of the State of Nevada has completed its examination of the books, accounts and business affairs of the Mark Twain Insurance Co. prior to the issuance of a license to sell insurance in Nevada according to company president C. L. Frisby.

It also was announced that Ronald C. Hemphill, 1176 Balzar, has been added to the company's local sales staff headed by regional supervisor Onward N. Abington.

In a special bulletin to all stockholders and subscribers regarding the issuance of stock for fully paid shares, Frisby reported:

"HAVING SURPASSED the financial requirements and met all of the other requirements, we are hereby complying with the final statute of the Nevada Insurance Code required before the issuance of our charter.

"This calls for the issuance of stock to all purchasers for wholly paid shares at the offering price of \$20 per share. Any balance or payments made after the examination will be credited towards the balance due on each subscription. The balance of shares will be issued on the completion of each subscription.

"By action of the Board of Directors you are hereby extended a one time and final opportunity to purchase additional units of capital stock at the same offering price. However, new subscriptions will not be accepted if present subscription payments are not now current. You should also make any referrals of friends or associates who might wish to become a part of the company on these terms.

"We are now in the process of training and licensing of our huge sales force. We will end stock sales on one day and begin insurance sales the next day with the largest and finest insurance sales force in Nevada. We will be backed by some 10,000 stockholders and a powerful advisory board. This, combined with the other elements of success now incorporated in the company, will make Mark Twain a major force in Nevada's future.

"We are pleased to be completing a job that many said could not be done. We are now preparing to put these same energies and enthusiasm to work for you by building Nevada's largest home owned insurance company.

"No stock will be issued for fractional shares and is only being issued for the amount paid in as of the date of the Commissioners examination."

Experts Agree Races "Equal"

MORE THAN A MONTH AGO, the VOICE revealed that a distinguished group of anthropologists, geneticists and biologists from 17 countries had found there is no justification for claiming one race is superior to another--either from an intellectual or physical viewpoint.

An official report by the 22 experts has now been issued in Paris, France, by UNESCO, the United Nations Educational, Scientific and Cultural Organization. The published report confirms the original story appearing in the VOICE.

One of a list of conclusions to which the experts agreed unanimously said:

"Neither in the field of hereditary potentialities concerning the over-all intelligence and the capacity for cultural development, nor in that of physical traits, is there any justification for the concept of 'inferior' and 'superior' races.

"The biological data (given in the report) stand in open contradiction to the tenets of racism. Racist theories can in no way pretend to have any scientific foundation . . ."

Other points made in the report included:

"It has never been proved that interbreeding has biological disadvantages for mankind as a whole.

"ON THE CONTRARY, it contributes to the maintenance of biological ties between human

groups and thus to the unity of the species in its diversity . . .

"The biological consequences of a marriage depend only on the individual genetic makeup of the couple and not on their race. Therefore, no biological justification exists for prohibiting intermarriage between persons of different races, or for advising against it on racial grounds . . .

"The peoples of the world today appear to possess equal biological potentialities for attaining any civilization level."

Signers of the report included Prof. Jean Benoist, University of Montreal, and Prof. Carleton S. Coon, University of Pennsylvania.
