ENDORSE CANNON FOR RE-ELECTION TO U.S. SENATE

THE DEMOCRATIC TICKET of Lyndon B. Johnson and Hubert H. Humphrey for President and Vice President of the United States has been formally endorsed by the Nevada Voters League. The group also has endorsed Sen. Howard W. Cannon in his bid for re-election.

Last week's meeting of the League failed to

produce an endorsement in the Congressional race between incumbent Representative Walter Baring and his Republican opponent, George Von Tobel

Despite the fact that representation at the state conventions of both major parties is based on the number of persons voting in the Congressional election, League leaders decided it was impossible as a matter of principle to endorse Baring, who voted against passage of the Civil Rights Law of 1964, or Von Tobel, who has publicly stated he would have done the same had he been in Congress when the vote was

Tabled for further discussion at a League meeting scheduled for 8:30 tomorrow (Oct. 23) night at 1401 North E St. was the question of who, if either, should be supported in the race between Jim Brennan and Murray Posin for Las Vegas Township Justice of the Peace. Both Brennan and Posin addressed last week's meet-

Also endorsed were Republican Rev. Donald Clark and Democrats Helen Herr and Mel Close Jr., for the State Assembly from District 2; Helen Lamb Crozier for State Board of Education, Harvey Schnitzer for County Hospital Trustee and Phil Cummings for County Public Administrator.

Hosts Pension

NEARLY 200 WELFARE and pension plans involving Nevada workers will be subject to review at a clinic scheduled for Friday, Oct. 30, at the Flamingo Hotel here. The clinic is slated to get under way at 9:30 a.m. in the Gold

Plan administrators, accountants, insurance agents, trust officers, attorneys, bankers, union Intereste employers and other sons are invited to attend free of charge.

Sponsored by the U.S. Labor Department's Office of Labor-Management and Welfare-Pension Reports, the 2-1/2 hour clinic will be specifically concerned with the requirements of the Welfare and Pension Plans Reporting and Disclosure Act of 1958 as amended in 1962.

The Federal law is designed to protect the interests of workers and their families who are dependant upon employee benefit plans for pension and retirement, or as protection in case of sickness, accident, unemployment or death.

Fred T. Ragsdale, area director of LMWPR, will preside over the clinic. A question period will follow main talks, after which the audience

may consult individually with any member of

"It is estimated that welfare and pension plans are valued at about \$66 billion nationally,"
Mr. Ragsdale stated, "Due to their economic importance, our objective is to help those in positions of responsibility, or in direct participation, to fully understand the law and its visions. The Las Vegas clinic will contribute towards this end."
