### "Sell-Out" Artists Must Be Repudiated Or We All Shall Suffer Consequences (An Editorial)

THIS NEWSPAPER HAS DECIDED TO ENDORSE JIM BRENNAN FOR JUSTICE OF THE PEACE FOR LAS VEGAS TOWNSHIP. WE HUMBLLY HOPE FOR YOUR SAKE AS WELL AS OUR OWN THAT HE IS ELECTED TO OFFICE NEXT TUESDAY.

Our endorsement of Mr. Brennan is not solely based on his many outstanding qualifications for this important office. Frankly, we are more concerned with forestalling a disaster that may overwhelm the Negro community if he is NOT elected.

We are sorry and ashamed to reveal that an attempt has been made to "sell-out" the Nevada Voters League--once the political pride of West Las Vegas and its colored citizens--for \$1,000!

The reported purchaser--who may have been the unwitting pawn of power-hungry political manipulators--is Murray Posin, Mr. Brennan's opponent in Tuesday's election.

The alleged seller, James Anderson, is a man who apparently aspires to become overlord of the Westside. Anderson claims he negotiated the reported "deal" at the behest of Nevada Voters League president Charles Kellar.

Without the knowledge or authorization of the Executive Committee of the Nevada Voters League, it is reliably reported that Mr. Anderson offered the League's endorsement to Mr. Posin for \$1,000. Mr. Posin was led to believe that the money would be used to finance a "Get Out the Vote" campaign in West Las Vegas to further the candidacies of League-endorsed candidates in the forthcoming election.

We do not object to legitimate efforts to raise money to "Get Out the Vote" or to support the candidacies of League-endorsed candidates. The VOICE has endorsed many of these same candidates (see sample ballot on page 3) and firmly believes they would make good public officials. Until we heard of the "deal" to endorse Mr. Posin, we had not even decided on an endorsement in the Justice of the Peace race.

WHAT WE DO OBJECT TO IS HAVING ANY PERSON OR PERSONS ARBITRARILY "ARRANGING" TO DELIVER THE ENDORSEMENT OF THE NEVADA VOTERS LEAGUE TO ANY CANDIDATE FOR A CERTAIN SUM OF MONEY, LARGE OR SMALL.

We consider such a "deal" an outright betrayal of the high purposes of the League and

a direct insult to those citizens who look to the League for guidance in selecting public officials of unquestionable integrity who will work for the best interests of all our citizens.

We ask you to consider the following chain of events:

Before leaving town on a business trip some two months ago, Mr. Kellar personally delegated his duties to Mr. Anderson, bestowing upon him the title of "campaign coordinator". Mr. Kellar's designation of Mr. Anderson was most confusing in view of the fact that the Rev. I. W. Wilson, pastor of Bethel Baptist Church, was the NVL vice president. Rev. Wilson was completely ignored by Mr. Kellar.

### SCHOOL DISTRICT OFFERS TAX, ANALYSIS CLASSES

TWO NEW COURSES will be offered by the Vocational and Adult Education division of the Clark County School District starting next Monday, Nov. 2, at Las Vegas High School according to director Raymond L. Sturm.

A 16-hour course in Personal Income Tax is scheduled for Room 202 each Monday from 7 to 9 p.m. Designed to acquaint students with proper preparation of personal income tax forms, the course includes how to allow for investments, itemized deductions and property sales. The fee is \$5 for the complete course.

Also booked for Mondays in Room 212 from 7:30 to 10:30 p.m. is a 50-hour course in Systems Analysis. This course will cover the principles, techniques and implementation of Systems and Procedures. Topics covered will include fact gathering, installation and follow-up, formalizing-procedure manuals, forms analysis and design, administrative work measurement, Survey of basic tools used in systems analysis, etc. The course will cost \$7.50.

Registration will be conducted at the opening classes next Monday.

Anyone interested in signing for a 30-hour course in Salesmanship at a cost of \$4.50 is advised to contact the Adult Education office, 401 1/2 South Ninth St. (384-7816 or 384-7817). This course will offer basic instruction in prospecting, pre-approach, approach, presentation, meeting objections, closing, follow-up, human relations, etc.
