GOVERNOR PLEDGES "STRONG APPEAL" TO LEGISLATURE

STRONG PLEAS for the necessity to "create a climate for acceptance" of the 1964 Federal Civil Rights Act and to enact "realistic" civil rights legislation on the state level featured Mayor Oran Gragson's Conference on Equal Opportunity at the Hotel Tropicana last weekend.

VOICE publisher Dr. Charles I. West, moderator of the wrapup session, expressed the opinion: "It is obvious, and also imperative," that effective steps be taken on the local, state and national levels to create a climate for acceptance" of the new Federal law. "The methods best suited to bring about tranquil compliance are what we seek in discussions such as these."

Gov, Grant Sawyer, making a brief appearance during the luncheon break of the day-long seminar, said he believed "the time is right for enactment of realistic civil rights legislation at the January session of the state legislature" and that he intended to make a "strong appeal" for passage of such legislation.

In his opening remarks, Mayor Gragson pointed out that "the NAACP did not initiate this seminar. We thought it was time for others to take the initiative, with all due respect to the NAACP. We are here to offer assistance and guidance and to seek the same from the NAACP. We recognize that organization as the leader in the civil rights movement and we want to work with it to bring about a better community."

Rev. H. Clyde Mathews of Reno, chairman of the Nevada Advisory Committee to the U.S. Civil Rights Commission, said the objectives of his agency was:

 To inform the public of opportunities made available by the 1964 Federal Civil Rights Act;
To acquaint the public with provisions of the law;

3) To bring together the best minds in the state to work out solutions to civil rights problems.

"LET US WORK today to lighter tomorrow's burdens," the Rev. Mathews said. He was introduced by M. William Deutsch, chairman of the Southern Nevada Human Relations Commission, which served as the host organization for the Mayor's conference.

Deputy Director John I., Binkley of the State Advisory Committees Division of the U.S. Commission on Civil Rights said that his agency was delegated to investigate and research the total subject of civil rights and report its findings to the President and Congress.

Binkley prefaced an outline of the more significant provisions of the new Federal law with the statement that, "This is the first state in which we have held a conference where the minority groups constitute less than 10 per cent of the total population. We have had only seven previous seminars, chiefly in southern states, where the percentage of minorities is quite high."

J. K. Heilborn of the U.S. Commission's Community Relations Service explained that his (See SEMINAR, page 14)
