GETTING DOWN To The MAIN BUSINESS

Text: "We Come Therefore As Christ's Ambassadors. It Is As If God Were Appealing to You Through Us: In Christ's Name, We Implore You, Be Reconciled to God!' (II Cor. 5:20).

A new bi-monthly church publication, on the

first page of its first number, has these words:

"You Must Therefore Be Like Men Stripped For Action," (I Pet. 1:13). Our calendars have become cluttered, our lives jam-med with much busyness. In this desperate age, so full of peril and promise, is there one thing our Lord summons us to do above all else? How do we strip for action?

These are incisive questions. Turning over the pages of the pamphlet, it would seem that the answers to these questions lie in more promotion by

boards and councils and committees, in other words more "clutter," more "jam", more "busy-ness." Is stripping for action tinkering with the organization of the Church, revising the by-laws, paying homage to acclesiastical dignitaries? Is it overconcern for political and social issues, not realizing that it requires new men to bring in a new day? Or do we strip for action by holding bigger and better Church parties, more profitable rummage sales; by

seasonal changes of color in the chancel?

What is getting down to the main business?

Let Paul tell us, for he was a Christian who

never became sidetracked.

Getting down to the main business is accepting a commission. Christ gives it He said, "All power is given unto Me in heaven and in earth. Go ye therefore and teach all nations' (Matt. 28:18-20). He said, "Go ye into all the world and preach the gospel to every creature" (Mark 16:15). He said, "Ye shall receive power, after that the Holy Spirit is come upon you, and ye shall be witnesses" (Acts 1:8).

Paul said that we are Christ's ambassadors. When we get down to the main business we shall

take that assignment seriously.

Getting down to the main business, we shall open up our lives to the power and the Spirit of Christ. An ambassador makes sure to keep the lines of communication open between himself and the sender. The sender keeps the lines open toward his ambassador. This is a matter of mutual concern. Prayer keeps the lines open so that power and inspiration are received. Action keeps the lines open as when Peter put out his hand to a cripple and lifted him up in Christ's name. The proclamation of the message keeps the lines open as when Peter's sermon is given the power to persuade.

When we get down to the main business we

Getting down to the main business is channeling the grace of God. It is as if God were appealing to you through us. The Church is a task force to bring men and women into a living, personal relationship with God. When the Church seriously accepts that responsibility, it will scrutinize its methods and activities, discarding the useless and unrelated. It will study to show itself approved. Channeling the grace of God is much like the irrigation of land-there must be contact with the source, no obstructions in the channel, an outflow upon the land. Getting down to the main business is taking God's grace

"In Christ's name," wrote Paul, "we implore you, be reconciled with God!" Getting down to the main business is accepting the trust of a message of reconciliation with God. It is knowing what that message of reconciliation is. It is actually proclaiming the message to others. It is intelligent and responsible and heartfelt witnessing for Christ, in the name of Christ, by the followers of Christ.

All else is as "a tinkling cymbal and a sounding brass.'

Virginia Abandons **Segregation Policy**

RICHMOND, Va.-- Virginia's State Board of Education has voted unanimously to abandon a policy of segregation by complying with the Civil Rights Act of 1964. It is the second Southern state board to publicly agree to sign the nondiscrimination pledges required for continued federal financial aid, joining Georgia. Numerous Southern colleges also have complied. Desegregation of Virginia's Department of Education administrative staff apparently is

Education administrative staff apparently is now assured, including the six Negro supervisors and their secretaries who are housed in an antiquated Richmond building separate from white officials.

Board chairman Mosby G. Perrow Jr., in announcing the decision, declined to go into details, but it was understood that a plan accompanying the signed statement to be submitted to federal authorities includes programs of desegregation in the following state activities: (See VIRGINIA, page 11)
