

**Balloting Tuesday**

**REELECTION FIGHTS FACE CITY OFFICIALS HERE, NORTH VEGAS**

TWO MEMBERS of the Las Vegas City Commission and the Judge of the Las Vegas Municipal Court are seeking reelection in next Tuesday's (May 4) primary. Unless one of the several candidates for each office is able to get more votes than the combined total of all other candidates for each office, the two top vote-getters will qualify for a run-off on June 8.

Las Vegas City Attorney Sidney Whitmore is unopposed for reelection this year and will be sworn in for another term on July 1, when other newly-elected city officials take office.

Commissioner Harry Levy faces nine opponents in Tuesday's primary, Commissioner Phil Mirabelli must contend against seven rivals and Municipal Judge Walter J. Richards is opposed by three other candidates.

Seeking Levy's seat on the City Commission are Glen O. Anderson, Edward Birch, Wes Howery, John Joliff, Miriam Kirschner, Andrew Maris, Dr. John Montgomery, Grant Stewart and Jim Wilson. Mirabelli's opposition comes from Alfred Becker, Gladys Dula, Joe Julian, Bert J. Leavitt, Frank R. Lester, Don Ream and Leonard J. Sperling. Those trying to retire Richards are Glen C. Jones, Sonny Richardson and Maurice Robbins.

All three incumbents have been endorsed by the Nevada Voters League. The Las Vegas VOICE is NOT endorsing any candidates in Tuesday's primary, but may express a preference for one or more candidates in the June 8 runoffs, if necessary.

IN NORTH LAS VEGAS, Tuesday's election will be final, with two seats on the City Council and the municipal judgeship at stake.

Mayor William L. Taylor is opposed by former mayor Earl Hartke and Bob Bradley. Running for the City Council along with incumbent John E. Myers are Bud Cleland, Edward J. Francis and Sidney Nasby. Seeking to oust Municipal Judge Dean Breeze is Joseph Norman Dotson.

All municipal contests in both Las Vegas and North Las Vegas are conducted on a non-partisan basis.

the great Nicklaus, Art Wall and Bob Charles. Last fall, two weeks after a mediocre performance in the Sahara Invitational here, Pete came up with perhaps his finest showing against top-flight competition when he tied Casper and

Jerry Steelsmith for first place in the Almaden Open at San Jose. Brown and Casper, (the latter has finished second in three T-Cs) shot 68s to Steelsmith's 73 in the playoff, with Billy eventually defeating Pete on the third hole of a "sudden-death" contest.

Brown also was runnerup to Bob McCallister in the Sunset-Camelia Open and tied for fourth in the Carling "World" last year.

DUE IN PART to his bad back, Pete has had a rough time of it on this year's tour. He collected \$150 in January's Los Angeles Open, was shut out at San Diego and in the Crosby at Del Monte (where "the cold rains really tore me up"), was forced to pick up at Tucson after being five under par for 36 holes, and remained on the "injured list" until the Houston Open two weeks ago, where he managed to pick up \$250.

But his strong showing at San Antonio, despite marked loss of strength on the back nines each day, has brought Pete to Las Vegas in a less than pessimistic mood.

"This warm weather is bound to help me, if it stays that way," he told the VOICE Monday after flying in from Texas. "If I can stay out of the heavy rough and get down a few putts, I may be able to beat some of them out there this weekend. I've been hitting the ball well the past couple of weeks, but I sure tire fast. We'll just have to wait and see what happens."

Brown, who now makes his home in Los Angeles with his wife and four daughters, has one consolation in playing here. In addition to being a "house guest" of the Desert Inn this week (which means he doesn't have to pay a penny for room and board), he is assured of at least \$1,000 in prize money. That's what last place pays in the Tournament of Champions no matter how poorly you play.
