A NEW ADVISORY GROUP has been selected by officials of the Clark County School District to consider the increasing number of educational problems facing this fast-growing area.

School board president Chester Sewell said the new group, composed of prominent citizens from various segments of the community, has been named the Clark County School District Planning Council. Prime purpose of the council will be to advise the school board on policy-making after careful examination of important problems such as de facto segregation.

William Moore, Dr. Marvin Sedway, Mrs. E. Parry Thomas, Mrs. J. A. Tiberti, Dr. Charles I. West, Woodrow Wilson and Adam Yacenda. A replacement for original appointee Jude Wanniski, who has left the area, will be made in the near future.

Dondero, assistant to the superintendent of schools and chairman of the Economic Opportunities Board of Clark County, will serve as executive secretary of the group.

APPOINTMENTS TO THE COUNCIL were made by the school board on the recommendation of Dr. Leland Newcomer, superintendent of Clark County schools, and his administrative staff.

Board chairman Sewell pointed out that school districts throughout the country have become increasingly concerned with the problem of providing equal educational opportunity for all children within their jurisdictions. Involved social and economic conditions in large cities and fast-growing areas such as Southern Nevada have complicated this problem to a point where school officials must rely on more help and constructive advice from community leaders according to Sewell.

"Some of these socio-economic problems are fast becoming top priority in Clark County," Sewell said. "They include such issues as elementary, junior and senior high school district-

City Inaugurates Kids' Day Camp At Tule Springs

FIRST DAY CAMP PROGRAM ever offered by the Las Vegas City Recreation Department will be available this summer to boys and girls, 7 through 11 years of age, at Tule Springs under the direction of Joyce Coleman.

Miss Coleman has 8 years experience with the YWCA as a day camp and resident camp director, as well as 15 years in specialized camping procedures. There will be three additional staff members to provide excellent guidance for all activities.

The city will provide bus transportation and pick-up and delivery of children will be at a different location each week so that youngsters all over the city will have an opportunity to attend camp. The bus will pick up at 8:15 a.m. and the children will be returned to this location before 5 p.m. each day. A staff worker will ride the bus each day with the children.

The program will provide many exciting crafts and projects never before offered in this area. There will be camp crafts such as weather-flag making, building and reading a barometer, Indian picture writing, making maps of trails, hiking and trailing, mosaics from nature, plaster casting, making and reading a sundial, as well as camp cookery, folk dancing and singing, sports and games.

Children must be registered a week in advance by contacting Miss Coleman at the Recreation Department, 385-1221, extension 374. There will be a \$3 fee per week per child for supplies and milk and cookies, which will be provided in the morning. The children will be requested to bring a sack lunch, and to wear shirts, socks, shoes and a cap. Swimming will not be a part of this program, because as yet the pool at Tule Springs is not open for public use.

Miss Coleman will provide training for young girls, 15 years or older, who are interested in gaining experience as future camp counselors. This Counselors-in-Training program will be offered on a no-pay basis. Girls will be interviewed by Miss Coleman and those interested in gaining this experience should contact Miss Coleman before June 7th, by calling at 385-1221, Ext. 374. The number of counselors will be limited, so girls interested in spending 10 weeks at day camp this summer should call without delay.
