# Advisory Group's Next Meeting Set; Breifing on July 19

EXTENT AND NATURE of the problems to be attacked by the recently organized Clark County School District Planning Council, specifically as they relate to the School Board's attempt to provide equal educational opportunities for all children in the county, will be presented at the council's next meeting on July 19 according to Chairman Robert Jones.

Jones said he had asked Harvey Dondero, executive secretary of the council and assistant to the county superintendent of schools, to organize a presentation of data on July 19 that will clearly indicate and identify the scope of the council's work.

At the council's first meeting on May 26, Dr. Leland Newcomer, superintendent of schools, posed a number of questions for consideration by members of the advisory group. They included:

I) Are there significant segments of our school population that are not profiting from their school experience as well as should be expected? If so, what is the nature and extent of this problem and what are its probable causes? And what is the responsibility of the School Board to expend its resources in an attempt to correct such a situation?

2) What is the effect of de facto school seg-

regation in Clark County?

3) What are the problems arising out of integration at the junior and senior high school levels?

4) What are the economic implications of de facto segregation, integration by transportation, compensatory education, etc., etc.?

It is expected that Dondero will present data and other pertinent information on all these points at the July 19 meeting, including detailed views of the School Board and the school district administration.

Jones expressed the hope that all council members, including those who missed the May 26 meeting, could arrange to be present on July 19. Members attending the original meeting were Mmes. # GRANT TV STATION SUIT ANSWER DELAY

AN ANSWER to a \$1,500,000 damage suit filed by the Rev. Prentiss S. Walker against KSHO-TV and its general manager, originally due last Friday, has been delayed until early next week at the request of attorneys for the insuror of the local television station.

Attorney Robert L. Reid, representing the Rev. Walker, said he had agreed to a 10-day extension of the answer deadline after confer-

ring with his client.

The suit resulted from KSHO-TV's midprogram "blackout" of the Rev. Walker's weekly panel-type show on April 11 following a protest from a local financial institution that it was being unfairly maligned by a guest on the program. The show was subsequently cancelled by the television station.
