

NLV Council Considers Park Petition Monday

ALL RESIDENTS of Valley View Estates are urged to attend a meeting at the North Las Vegas City Hall next Monday, Aug. 16, at 7 p.m. when a petition asking for "action" on a proposed public park in the Valley View Estates area will be considered by the city council.

The petition was drawn up and submitted to the city authorities by Raymond Blankes Jr. of Valley View Estates at the request of residents of the area. Blankes estimated that more than 500 families totaling about 1,500 persons are represented on the petition turned over to the

city clerk last Monday.

Funds were appropriated for the proposed park some two years ago according to Blankes, but the money allegedly was used for recreational facilities in older sections of North Las Vegas.

Many Schools Open For Pre-registration Starting Next Week

REGISTRATION DATES and enrollment procedures for the school term starting Sept. 7 at high schools and junior highs in the Greater Las Vegas area, and elementary schools in West Las Vegas and the adjoining section of North Las Vegas, vary in many important respects this year.

The Las Vegas VOICE has compiled the following comprehensive summation of various releases from the Clark County School District dealing with registration dates (and hours where available), together with other pertinent information on enrollment procedures of particular significance to Westside school children and their parents. Supplementary or clarifying details may be obtained from the district administrative offices at 2832 E. Flamingo Rd., telephone 736-5011.

Regular registration at all Clark County schools will be conducted on Sept. 2-3. However, district authorities emphasize that students scheduled to attend Rancho and Clark High Schools and Roy Martin Junior High who are not already enrolled should pre-register as soon as possible.

Students at these three schools will have their class programs computerized this fall and all data must be gathered and processed at Stanford University by Sept. 1. Failure to pre-register at the earliest opportunity could place Rancho, Clark and Roy Martin students at a disadvantage when classes start Sept. 7.

Pre-registration not only is most helpful for planning purposes at all county schools according to district authorities, but in those cases where class programs have been mailed out, students who pre-register are able to check them against programs previously assigned for possible errors so that corrections can be made on the regular registration dates of Sept. 2-3. This is important because no changes in "official" student programs will be permitted for at least two weeks after school starts.

As noted above, students attending RANCHO High for the first time this fall are requested to pre-register at the school by Aug. 27. At the regular registration on Sept. 2-3, 12th graders

EXPECT NEW SCHOOLS TO BE READY ON TIME

DESPITE CONSTRUCTION DELAYS caused by labor disputes, county school district authorities are reasonably certain that all nine new schools scheduled to start classes on Sept. 7 will open on time.

Only two of the seven new elementary schools are in the Northern Section attendance area, comprising West Las Vegas and the adjoining portion of North Las Vegas. They are Jo Mackey and Marion Cahlan. However, many Westside school children are scheduled to attend the new Clark High while a number of colored students from other sections of the county are enrolled at the new Valley High.

report at 8:30 a.m. on Sept. 2 and 11th graders at 10 a.m. on the same date. Tenth graders report at 9 a.m. on Sept. 3 for final checkouts and orientation, with parents urged to attend.

WESTERN High students who have not already received a program of classes for the fall semester must report to the school on Aug. 25, 26 or 27 from 8:30 a.m. to noon or from 1:30 to 3:30 p.m. Assignments will be made and books distributed at the regular registration on Sept. 2-3. Those receiving class programs by mail will follow attached instructions.

Pre-registration at LAS VEGAS High starts on Aug. 16 while enrollment at the new CLARK High for students who did not attend a county school during the past year is now in progress, Monday through Friday from 9 a.m. to noon, through Aug. 20. Students already pre-registered at Clark High who discover discrepancies between previously assigned classes and schedules received in the mail should check with counselors at the school between 1 and 3 p.m. by Aug. 20.

Orientation sessions for Clark High students and their parents will be held from Aug. 17 through Aug. 20, with all students required to report for regular registration at 8:30 a.m. on Sept. 2 and at 8:25 a.m. on Sept. 3 for abbreviated classes until noon. Pre-registration of students new to the county and not previously enrolled is set for Aug. 30-31 at 9 a.m. Eighth grade orientation is scheduled for Aug. 17 at 9 a.m., with parents of 8th and 9th graders invited to meet teachers and tour the school at 8 p.m. the same evening. Ninth grade orientation is slated for Aug. 18 at 9 a.m.; 10th and 11th grades on Aug. 19 at 9 a.m. Parents of 10th and 11th graders will be able to meet the faculty and tour the new building at 8 p.m. on Aug. 19. Aug. 20 has been set aside for Clark students unable to attend the orientation sessions designated above.

Pre-registration at the new VALLEY High will be conducted on Aug. 26-27 according to last-name initials starting at 8 a.m. each day. Orientation sessions are scheduled for Aug. 30, Sept. 1 and 3 according to grades.

LOCAL CIVIC GROUPS PLEDGE ASSISTANCE TO JULEART EVICTEES

EFFORTS TO AID needy tenants of Juleart Trailer Park who face eviction from the condemned Westside court on Aug. 31 continued this week after various aspects of the situation were discussed at the monthly meeting of the Las Vegas NAACP at Kit Carson School last Sunday.

Mrs. Pat Fahey, representing the Policy-Action-Leadership (PAL) committee of the county-wide Catholic Welfare organization, explained that her group supported closure of the controversial 'H' St. and Owens Ave. court, a move that had been spear-headed by the Housing Committee of the local NAACP, but that PAL wanted to be sure that all families dislocated by the shut-down would have "someplace to go."

She said PAL became involved in the "unfortunate" situation after requests for help from low-income families to the county welfare department were referred to the Catholic organization.

Frank Anderson, retiring chairman of the NAACP Housing Committee, said the NAACP recognized the seriousness of the situation and would render all possible assistance in relocating the evacuated families.

The city commission ordered the trailer park vacated by Aug. 31 after denying an application for variances from the city code submitted by the owner and operator of the court.

Examinations Scheduled For Post Office Openings

NEW REGISTRATION for Clerk-Carrier positions in Southern Nevada post offices is now being conducted by civil service authorities according to Las Vegas Postmaster Robert Lias.

Starting pay for first and second class offices is \$2.48 per hour; for third class offices, \$2.12 per hour.

All applicants are required to reside within the delivery zone, or be bona fide patrons, of the post office for which they are applying. All applicants must take a written examination that requires about three hours to complete.
