NEWLY APPOINTED Nevada Commission on Equal Rights of Citizens executive secretary James Anderson this week was preparing to set up offices in the local State Building at 215 E. Bonanza Rd.

The Las Vegas advertising and public relations man was named to his new post last weekend by Gov. Grant Sawyer following a recommendation by the five-member agency that is primarily responsible for enforcing state.

equal rights legislation. Anderson, 50, was born in Taladega, Ala., and educated in Muskogee, Okla. Before coming to Las Vegas several years ago, he was active in labor relations and civil rights work in the Los Angeles area after serving as an Air Force identification specialist in World War II.

He has been serving as chairman of the Las Vegas NAACP labor and industry committee and as a job coordinator for Operation Inde-pendence in its relations with the National Youth Corps,

Anderson played a prominent role in drives for Nevada civil rights legislation during the 1963 and 1965 sessions of the state legislature.


