Reapportionment Proposal by NAACP Officials Draws Bitter Protests

State Legislators Mull Requests By Opposed LV Negro Groups EGAS

Community Majority Vigorously Rejects Negro District Idea

STATE LAWMAKERS, currently engaged in trying to reapportion Nevada's legislative districts in conformance with the U.S. Supreme Court's "one man, one vote" edict, this week were mulling two resolutions from opposing segments of the Las Vegas colored community.

One resolution, drafted on Oct. 22 at an apparently constitutionally legal meeting of fewer than half the members of the Las Vegas NAACP executive committee, urged "the Governor and all Legislators to support a plan of reapportionment" that would include "a cohesive district laid out in Las Vegas which would guarantee representation to the Negro people of Clark County and a fair opportunity to elect representatives of their choice to serve them in the reapportioned legislature.

The other resolution, drawn up following a lively three-hour "town meeting" type of gathering at The Cove formerly the Carrelled on the New York Cort 21 melled on the New York Cort 21 me House) last Sunday, Oct. 31, called on the Nevada Senate to avoid creating an election dis-trict here based on "race, color or creed."

It was emphasized by many who opposed the creation of a so-called 'Jim Crow district' that they would be happy to see a Negro in the state legislature, not on the basis of his or his constituents' color, but because he possessed the ability to fairly and intelligently represent a well-defined and heavily populated geographical area with problems peculiar to the area.

THE SECOND RESOLUTION, reflecting the vigorously expressed views of a substantial majority of the West Las Vegas Negroes who attended Sunday's crowded open meeting, was (See STATE, page 14)

ARE COMPLIANCE" TOO LITTLE-SAWYER

Few gains in civil rights would have been possible without laws, yet this force is not enough to bring about true equality, Gov. Grant Sawyer told an Equal Rights conference Friday, at the Mint Hotel.

'MY purpose is not to urge compliance with this statute, for I feel every Nevadan will fulfil the obligations placed upon him," Sawyer said about Nevada's 1965 civil rights law.

"Rather, I hope we will realize that bare compliance with the law is but a token on the debt of discrimination. In Nevada, too many of our people have only a token opportunity to participate fully in many areas of life."

THE fight for civil rights must be won hand-inhand with the federal war on poverty, Sawyer said, so that minorities will be qualified to take advantage of the new-found opportunities.

SEVEN MONTHS AGO, I signed AB 404, which became the 1965 Civil Rights Law. It was an historic event, made possible through the good will of Nevadans of different parties and different ethnic and racial origins, and we hailed the bill as the most significant move toward equality in 100 years of statehood.
