Just a brief note to express to you, and my other friends in West Las Vegas who are opposing the establishment of a separate Assembly district for West Las Vegas, my sincere wishes for your success.

The many arguments made against this--as I read them in the public press--are substantial and factual and I hope they prevail; however, doctor, in my opinion as a former member of the State Legislature, one of the very most important reasons West Las Vegas should not be established as a separate District is this; Just so long as the voters of West Las Vegas have the opportunity, as they do now, to vote for the Assembly representatives in ALL of Las Vegas District the West Las Vegas vote is important to these office-holders and office-seekers and, per se, the desires and needs of its residents will receive proper consideration. For the past year, I have been battling constantly to get delivery of completed homes built by Rohr Aircraft Corporation for Windsor Park, so that approved home owners could make plans to move into their new homes.

Although promise after promise was made for early delivery of homes, buyers had to wait for several months after they were approved by the FHA to move in. In addition to the aggravation of constantly having to make excuses for these unwarranted delays, I found, in many instances, that the homes scheduled for delivery by Rohr Aircraft were not up to the standards and specifications expected by Windsor Park developers.

Rather than compromise the high standards set for better housing for my people, or see my dream shattered for a community of "lived-in homes" instead of a typical tract of vacant houses, I decided not to let the failure of Rohr Aircraft's performance defeat my plans for the Windsor Park project. Instead, the project will not only continue, but certain improvements will be added to future homes to give the buyers even more for their money.

I have negotiated arrangements for Windsor Park to build its own homes. Construction is now under way for a new unit of 71 homes under my personal supervision.

This will insure my people that they are going to get the type of home that I have been fighting to get for them for so long! One that is priced right to meet their pocketbooks and will not fall apart after the builder has taken the people's money and left town.

These new homes are going to be built strictly according to the plans and specifications approved by the Federal Housing Administration, and will not be turned over to the home owner until I am completely satisfied that they are really ready to be lived in.

I want the people to know that I will stand behind any promise that I have made in the past. Sincerely,
