Z. Louie, who owned the club from 1955 to 1961, proposes to buy out present owner Andy C. Wong. Louie has been managing the club for Wong since 1961.

Applying to retain their positions as corporate officers without investment are Walter E. Minor, a Las Vegas slot machine mechanic, and Dale B. Dorothy, a Las Vegas realtor.

The license application seeks authority for operation of four table games and 10 slot machines. The proposal will be considered by the Gaming Commission upon completion of routine personal background and financial investigations by the State Gaming Control Board, Earliest possible licensing date is March 15.
