

CLAY - TERRELL FIGHT HANGING ON LEGAL THREAD

Illinois Attorney General, WILLIAM G. CLARK may, by this time, have declared his legal opinion of the "to be or not to be" status of the scheduled March 29 world heavyweight championship bout between CASSIUS CLAY and ERNIE TERRELL. As CHUCK writes this, the whole rhubarb has been left solely to the judgment of the Illinois Attorney General who has already rendered an opinion that the fight could not legally be held in Illinois due to illegal licensing of the promoters as shown on the pending application.

Promoter IRVING SCHOENWALD, speaking for himself and his partner, BEN BENTLEY, promptly withdrew the application of their corporation, NATIONAL SPORTS PROMOTIONS INC. to stage the bout announcing that he, as an individual would reapply to promote the fight.

CLARK's opinion, which may amount to Ten Count over the scheduled bout, came shortly after CLAY refused to apologize to the Illinois Athletic Commission for his alleged "unpatriotic remarks about the draft". But the CHAM-PION's comment before the commission prob-

ably had knocked out the proposed fight anyhow.
"First of all", he began, "I'd like to say
I'm not here to make a show down plea. I'm not here to apologize in any way such as the Press has predicted I would. People advised me to call here because certain people would be hurt over what I said. My apology is only to the Press. I apologize for opening my mouth on things which should have been taken up with only those dying or hurt in Viet Nam. Anything else with the Army or the draft will be taken up with those people. I apologize for having made those statements to reporters".

In the meanwhile, TERRELL is beginning to feel as though he will never climb in the ring with CLAY even though reports are that other states are interested in holding the match. TERRELL said the Commission should have the sole power to sanction bouts and shouldn't have to get permission from politicians. TER-RELL also said that it isn't good for boxing to have this bout stopped at the whim of certain individuals.

BOBBY ALLEN, our lightweight sensation, will soon head for New Zealand for a series of bouts . Sorry Saturday nights' boxing tournament at CHUCK's ALL AMERICAN BOYS CLUB had to be called off because of the flu epidemic. . . They are scheduled again for this Saturday night (Mar. 5) and don't forget admission is free.
