Clark High School "Incident" Fact Finding Committee Report

REPRESENTATIVES OF THE news media who attended the Press Conference held at the Clark County School District Office, Tuesday morning, to hear a report and recommendations from a special Fact-Finding Committee appointed by Dr. David A. Sands to investigate the February 25 Clark High School "incident" were considerably smarter than this reporter if they left the Conference any wiser about what actu-ally did happen at Clark High School.

Dr. Sands greeted reporters with an expression of appreciation for the tact, diplomacy and cooperation accorded the District by them, and then read a two-page summary of the Commit-tee's report and recommendations prefaced by an introductory page of explanation as to the initiation of the Committee; its assignment and

immediate objectives.

The introduction stated that on Monday, February 28 (following the "incident of Feb. 25) Dr. Sands appointed an ad hoc investigative committee consisting of Chairman Robert Bailey (Chairman of the State of Nevada's Equal Rights Commission), Reverend Marion Bennett (President of the local NAACP), Mrs. Reba Dolan (Regional Vice President of the PTA), Reverend Jerry Furr (Trinity Methodist Church), Rabbi Aaron Gold (Temple Beth Sholom -Human Relations Commission), Dr. Jacob Orleans (Professor of Psychology at Nevada Southern University) and Robert Reid (Attorney-

THE SPECIFIC assignment of the Committee was (1) to determine the factor or factors which precipitated the incident (2) to determine what actually occurred (3) to determine what was done to prevent the disturbance from escalating

into a more serious situation.

The immediate objectives of the Committee were to provide an objective picture of exactly what occurred in order that the school administration can take appropriate steps in connection with the particular incident and to increase the chances that no student or faculty member is unjustly accused of unsubstantiated behavior.

Now, in this writer's opinion, the selection of committee members was an excellent one, and I am totally convinced that the Committee made a thorough and exhaustive investigation. I accept, with little reservation, the Committee's "General Findings" report that "the incident of February 25, 1966, at Clark High School was clearly not a racial one", as I do "The Committee's interpretation of all the evidence gathered is that almost all the two hundred Negro and one thousand seven hundred fifty white students at Clark High School get along amicably, and that there is little, if any, friction between the vast majority of the Negro students and the teachers'.

However, understandably, (but much to an inquiring reporter's frustration) the Committee's actual report of taped interviews with students, parents, and teachers were of such confidential nature, they are not to be revealed.

AFTER DR. SANDS presented the summary of the Committee's Report to the reporters present, he and Bob Bailey answered the probing questions put to them with all the skill and dexterity of a polished politician which, in fact, present day School Administrators, almost

necessarily, are.

Neither Mr. Bailey nor Dr. Sands hedged the issue of an existing problem, however, and neither denied the probability of likely re-occurrences. Both agreed that this is a total community problem, not just that of the school district and frankly regretted no forseeable immediate resolution of the problem.

Probably more than any other person in the room, with the exception of Bob Bailey, I felt the stark staring tragedy of the whole situation. This incident at Clark High School that eventuated into a full scale rebellion of Negro students; (and mostly girls) against the administrative and teaching personnel of the school may not have been predicated on racial conflict, but do the Committee members (all of them), the school administrators, the teachers, the society in which we live realize that, with rare exception if any, there is no Negro man, woman or child, even those few that are blessedly free of prejudice themselves who is ever for a moment free of race consciousness.

This is not meant as a refutation of the report of the Committee, nor is it meant to "whitewash" the actions of the Clark High School students who reveled in such a blatant display of defiance against authority.

No, this is more of an agonizing racial selfappraisal, and even, if you can understand it, a plea for help--not from the white society, but help from our own for our own. (See Editorial).
