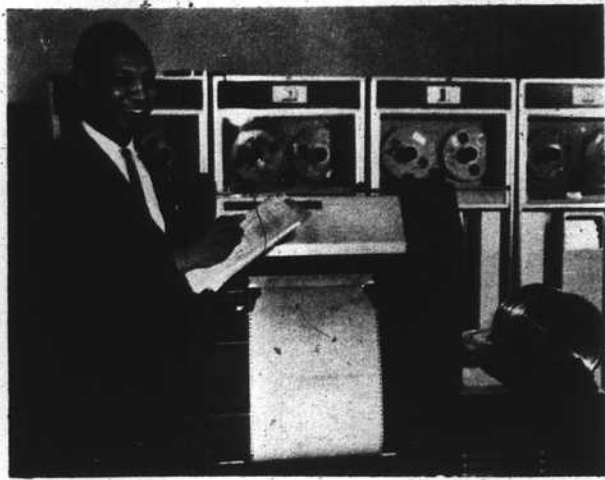


# Young Man With A Big Responsibility



JOHN MOORE is a young engineer who shares the responsibility for one of the most important functions of EG&G, an electronics and nuclear science firm which supports Atomic Energy Commission and Space Nuclear Propulsion Office programs in Nevada.

Moore, a 26-year-old Las Vegas, works with EG&G's Computation and Analysis Department. It is his job to help analyze technical information, and produce reports from which AEC scientists evaluate how their nuclear explosives are performing in underground test operations at the Nevada Test Site.

**HERE'S HOW IT WORKS:** When a nuclear device is detonated underground, dozens of sensitive instruments measure its performance in the instant before they are destroyed in the blast. The information is relayed to other instruments which display this data in the form of lines measuring a half-inch each. These lines--called traces--must then be broken down into a mathematical language which is then processed through an electronic computer. The computer, in turn, produces new line segments which look like dis-assembled portions of a graph.

Moore and his colleagues have the painstaking task of fitting these segments together so that the finished product is one long unbroken curve. From this curve, scientists are able to determine how well their nuclear device performed, and how much yield it produced.

**ESSENTIALLY,** this lengthy curve is the life story of a nuclear test, and it covers a period of time lasting something like a billionth of a second.

Moore has been performing this kind of data analysis for most of the four years he has worked with EG&G in Las Vegas. A graduate of Tennessee State University, young Moore came to EG&G in 1962 with a bachelor of science degree in Engineering.

"The truth is, I came out to work here one summer and just never got away," Moore said. "It's fascinating work; I don't think I'd be happy doing anything else."

Moore lives at 124 N. 13th Street with his wife, Alice, who works as a cashier at the Las Vegas First National Bank.

Clark County Economic Opportunity Board Chairman, Harvey Dondero, notified each Board Member, last week, of the resignation of the Board's Executive Director, Mrs. Elaine Walbroek.

Mrs. Walbroek will vacate her position, June 15 to return to the University of California School of Public Health where she has been accepted as a candidate for the degree of Masters in Public Health Administration.

In individual letters to the Board Members, Dondero stated that it was "with regret" he made the announcement of the Executive Director's resignation and that "I know many of us who have worked over the years with Mrs. Walbroek in developing the Economic Opportunity Board and in poverty programs predating the Economic Opportunity Act will feel keenly her loss to the Board and to the community."

## S.S. Beneficiaries Who File A Tax Report

ED COCKS, DISTRICT DIRECTOR of the Social Security Administration, offers valuable information for those receiving federal social security benefits in 1965 who must file an Income Tax report by the April 15 deadline. Because many social security beneficiaries are not aware of requirements for filing income tax, it is suggested that the following detailed outline of the circumstances under which some beneficiaries must file, be read with careful attention.

If you received federal social security benefits for any month in 1965 and earned over \$1200, you must file a report of earnings with the Social Security Administration on or before April 15. If you applied for social security monthly benefits but did not receive benefits in 1965, you should also file a report no matter how much you earned, as you may be entitled to social security payments for some months.

**YOU MUST FILE** this report of earnings on or before April 15 or face the possibility of losing additional benefits. If your taxable year ends at a time other than December 31, you must file a report of earnings within three months and 15 days of the end of your taxable year.

To determine how much your earnings were in 1965, add up your salary, commissions, vacation pay, net profit from a business of your own, and any other earnings from employment whether or not your wages were subject to social security taxes. Payments such as room and board, meals, or any payment other than in cash or by check, must be figured in, too, except those payments made for farm or household work. Income which was not earned from your employment of self-employment does not count as earnings.

When determining whether or not your earnings exceed \$1200 in 1965, be sure and include all earnings for the entire 12-month period even though you did not file your social security claim until well into the year. In figuring your earnings for a year, count everything you earned during each and every month. It is easy to overlook this.
