

The Temple Bar (Arizona) arm of Lake Mead

still rates as the boss fishing area for our money.
On Saturday, the 19th, Big Maizie put in at
Hemenway at 2 p.m. Long-Winded Bishop, the 100-pound Monster, (Ricci Carter) and yours truly had smooth sailing enroute to the Sandy Point area 20 miles above Temple Bar. We reached our destination around 3:30 p.m.--only an hour and a half trip by water.

We took about 25 dozen of Ann's 'lucky minnows'. The actual head count was probably more than 30 dozen. Ann got to "jawing" with champ Long-Winded and lost count a couple of times. She still counts real good for our money, even when she isn't trying to talk and count at the same time. On top of her generous counting, Ann's minnows are just plain lucky. They just seem to call the fish right up to the boat.

We have had some real boss catches of Crappie in our day, and we have also seen some mighty big hauls brought in by other nimrods, but the catch we had on this outing topped them all. The three of us brought back six boxes of fish--each box filled to capacity with fish--no ice. There wasn't room for a piece of ice or one more fish in any of the six boxes. The total weight topped 500 pounds.

We caught 20 Bass in the 1-1/2 to 2 pound class. There is no doubt that we could have easily limited out on Bass if we had made a try for them. We had to split the scene at dawn so as to save the quarter ton of fish we had aboard.

We used all of our Crappie minnows by daybreak. We would have run out of bait before midnight if Bish hadn't got tired of sticking his nine fingers trying to bait-up as fast as "Fast-Bait-Colbert. He put on a lure that he called his Red Spook. It was new to yours truly, and as yet we don't know what-in-hell it was, but it sure caught Crappie. Bishop must have caught at least 75 fish on his Spook.

We put on a red and white go-getter and added another 30 or 40 Crappie to the creel.

THIS HOT SPOT PRODUCED fish continuously from the time we got Big Maizie anchored, right up to the moment we left for home. As a matter of fact, the 100-pound Monster caught two Crappie while we were lifting anchor.

The spot does not have any official name. It is not designated on any map we have seen. From now on, the Crappie Catcher will refer to this spot as, "6 Box Point". It is on the starboard side going toward Sandy Point. The point can be located by a new road that comes out of the mountains right down to the base of a Cove which is bounded on its far side by 6 Box Point.

The point has a shallow rock reef that runs out into the lake. 50 feet downstream (toward Temple Bar) the water is over 50 feet deep. About 200 feet above 6 Box Point, there are two small islands -- Sandy Point is about another half mile above these islands.

GOING FROM TEMPLE BAR toward Grand Wash there is a big red cliff which we called the half-way mark in the good old days when we fished Grand Wash. There is a second, but smaller, red bank about a mile and a half above the half-way marker, 6 Box Point is about 1/2 mile beyond the second red bank.





THE BIG FIGHT

CANDY BARNES, one of Nevada's brightest boxing hopes, (and formerly managed by one of Boxing's all-time Greats, HENRY ARMSTRONG) has taken the Nevada Boxing Commission, Promoter BILL MILLER, Fighter LARRY CLARK and Fighter BOBBY ALLEN on in what he terms "Just a warm-up before he meets the winner of Monday night's fight at the Hacienda Hotel"-billed as a State Lightweight Title Bout.

It was publicly announced that BARNES qualified himself for the chance at the vacant title by eliminating all but one of the contenders in the elimination run-off.

MR. ALLEN is the one contestant who would not make himself available to be used as a punching bag for the Candy Man. Numerous offers were made to MR. ALLEN to face BARNES. In answer to the most recent offer, BOBBY BOY announced that he was going to New Zealand to engage himself there.

BARNES was first given the green light for the Fight with CLARK. However, CANDY did not find Promoter BILL MILLER'S terms and conditions reasonable, and told MILLER that he was not turning down the Fight, but the conditions.

MILLER is a Fight Promoter and Matchmaker, and can put together a match faster than Carter can produce little liver pills. With no problem at all, he gets hold of BOBBY BOY, and says "sign here". MR. ALLEN, reportedly, signed for less than the offer made to BARNES.

THUS, starts round one of the Big Fight. BARNES submits a formal complaint to the commission which, in essence, states that ALLEN has been a repeated loser in the past, inactive for six months, and had refused to meet BARNES in the eliminations. It further stated that, on the other hand, he (BARNES) had been a repeated winner, and active. The complaint also charged that he was not given sufficient time in which
