Multi-Racial Company In "In Crowd" Terms

NEW YORK--An imposing array of executives make up the integrated management slated to head a "multi-racial" insurance firm whose total capital will be more than \$4 million.

The capital to establish what is believed to be the nation's first so designated insurance company -- as opposed to "interracial" was presented to Intramerican Life Corporation by Franklin National Bank in a recent check-passing ceremony.

The designation "multi-racial" will keep the company from being considered a "Negro" insurance company, its chairman-president, Clarence Jones and other officials explained.

Jones, an attorney and adviser to Dr. Martin Luther King Jr., Southern Christian Leadership Conference director and Nobel Peace Prize winner and Livingston Wingate, former director, Haryou-Act, Inc., spearhead the board of direc-

Other members are entertainer, Harry Belefonte, Herbert L. Barnet, chairman, Pepsi Cola company; George Gray, president, Kings County Trust company and Clinton Miller, president Dime Savings bank, Brooklyn; Walter Wheeler Jr., chairman, Pitney-Bowes corporation and D. Parke Gibson, president of his own researchpublic relations firm specializing in Negro

Robert Randall, associate actuary, Teachers Insurance and Annuity Association and the College Retirement Equities fund, will head the life insurance subsidiary.

The company, which has issued 430,000 shares of common stock at \$10 a share, plans to extend its operations into financial areas other than insurance. Its sales efforts will be directed to urban and suburban areas where the growth of middle and upper income families among Negroes in the main, has established an expanded life insurançe market.
