## GOING TO WORK FOR YOUR HUSBAND

Professor Sendak, who teaches business management, has this to say on a subject of which there are several diverse points of view.

"Psychologically, a wife can free herself from imagined boredom of housekeeping by packing her children off to school and going to work for her husband in the family business.

In any small business, a wife can meet people, gain useful business experience, and build a base for a second career. If she earns money, she can improve family finances. If she works without pay, the business and the family can benefit directly from her free labor.

A capable, interested wife can be expected to work more conscientiously and effectively than will a disinterested outsider. She can increase total management "know how" - a sore need in small business - on the theory that two minds can have twice the brain power of one, not to mention the (always wonderful) woman's touch, as she supplements her husband's talents with her own.

There will be less worry about employee honesty and trust and with the business experience she gains, a wife can be better prepared to carry on the business in the event of death, illness, or absence of her husband.

**BUT WILL IT REALLY WORK?**  
Working together, wife and husband would see each other virtually for 24 hours, daily, and, among the other less desirable aspect of constant companionship, even the variety of discussion topics is narrowed for two people who normally would have differing experiences. Worse, during these 24 hours, both parents are taken away from their children, and no one is left to look after the home, to fix dinner, do housework, and tend children.

CONSIDERATIONS such as these call for real introspection by both husband and wife undertaking any joint business venture. Is the real motivation for the wife's working to help her husband and family financially, or, is it a cover to watch his every move and dominate his business as well as his personal life?

Concerning domination, the wife must recognize that no business can have two masters. A wife must be prepared to take orders from her husband and, although her views may be offered, ultimate responsibility for decisions must be his. There can be no room for resentment or "I told-you-so" when a decision sours.

Being the Boss's wife, a woman may find that some male employees (her husband included) dislike working for women, especially women who act bossy because they are bossy wives.

Further, a wife can become a disrupting influence, by throwing back in her husband's face his business mistakes and by bristling jealously when she sees special efforts made to please distaff customers. Displayed before employees and the public, such immature thoughtlessness can destroy a man more effectively than being called "Lover Snookums" to his everlasting embarrassment.

Finally, neither husband nor wife can avoid considering the impact of the husband's possibly having to fire, or in the least, chastise his wife.
