WASHINGTON - (NPI) -- An investigation of the Federal Bureau of Investigation's impact on civil rights and the replacement of FBI chief J. Edgar Hoover have been urged by Dr. Arnold S. Trebach, director of the human rights program, Howard University.

Addressing a committee meeting on administration of justice at the White House Confer-ence "To Fulfill These Rights," Trebach de-scribed Hoover and the FBI as "No. 1 untouchables.

Trebach proposed that Hoover "be replaced as soon as possible" not by a man of his own choosing, but by an individual of the "caliber of a Supreme Court justice." "It is a popular notion," Trebach said, "that

Hoover has no real belief in civil rights."

A FORMAL Congressional investigation of the FBI should be "patient, calm, efficient, and non-hysterical," Trebach said. "We should in-vestigate the FBI's role in American life and its impact on civil rights.'

"We cannot implement the council's recommendations unless we can deal with the FBI in a calm, effective way," he declared. He was referring to recommendations of

the White House Conference which supported President Johnson's "Great Society" program.



NEW YORK - (NPI) -- A proposal to name a Mississippi veteran's hospital for the late Rep. John E. Rankin, (R-Miss.) met with stiff opposition from the American Jewish Congress which sent a communication to the House of Representatives urging rejection of the move, on grounds that Rankin was an "arch-segregation-ist, white supremist and racist."

The AJC said "It would be shocking if a gov-ernment facility open to veterans of all races and religions were to be named for a man whose hatred for Jews and Negroes was so intense and so notorious as to have become a veritable fetish.'

They also accused the late congressman of referring to Solicitor Gen. Philip Perlman as "our Yiddish Solicitor General," and repeatedly referring to Negroes as brutes and also saying that slavery was the greatest blessing the Negro ever knew.

## Southwest Gas Report-So What Else Is New

Southwest Gas Corporation operating revenues reached \$13,870,028, E.M. Byrge, treasurer for the natural gas utility reported today.

This is a 19% increase over the comparable six months a year ago, when revenues for the corporations' three-state operations were \$11,-

643,619. "Our earnings also have continued the upward trend of the past several years," Byrge said. "For six months ended March 31 earnings were \$1.09 per share on 2,149,098 average common shares outstanding, compared to \$1.04 on 8% fewer shares for the same period a year ago.

ON APRIL 27, Southwest Gas increased its ,

For the six months ended March 31, 1966, quarterly dividend on common stock from 20¢ serves nearly 80,000 customers either directly to 25¢ per share, payable June 1 to stock of record May 10. This is the second dividend increase in its current fiscal year. On December 1, 1965 the rate was raised from 15¢ to 20¢.

"The 19% increase in revenue over the same period last year reflects the growth in number of customers," Byrge said, "since temperatures, which can affect heating revenues, have been close to normal this year.

Byrge said that in Nevada, where 77% of Southwest Gas utility plant is located, economic conditions are favorable. The index of general business activity for January 1966 increased nearly 6% over the same month in 1965.

"These are the three fastest growing states in the country," Byrge stated, "which is an important factor in our past as well as our future growth."
