# NAACP Coordinates Westside Drive

REV. MARION BENNETT, President of the local chapter of the NAACP, announced this week that, in keeping with the NAACP's National Program on Voter Registration, the Las Vegas branch will institute a crash voter registration drive coordinating its efforts with that of other civic groups registration programs.

Woodrow Wilson will serve as Chairman of the Registration Committee which includes Attorney Earle White, Registration Chairman for Nevada's Voters League; Gwen Weekes, County Election Board; Gloria Rome and Stella Fears, President and Registration Chairman, respectively, of Democratic Women's Club - West.

A non-partisan organization, the NAACP will coordinate the efforts of all groups working in the West Las Vegas area. Thirty area captains will supervise the activities in many neighborhoods.

NAACP Youth Council will be part of the task force seeking out unregistered citizens, and reporting this information to the NAACP Registration Headquarters at 960 West Owens in the Golden West Shopping Center which will be under the management of a professional coordinator.

Chairman Wilson said "We will provide the community with a weekly report on our activities. Call us and we will call on you to register you. Remember Voter Registration deadline is July 23. To be eligible to register you have to have lived in the state of Nevada for six months, and at your present address for 10 days.

"Without a vote, you have no voice, and have no say in SEPTEMBER--YOU MUST REGISTER NOW".
