

CIVIL RIGHTS AND GLORY

MADISON, Wisc. - (NPI)--A couple from Dolton, Ill., has filed a \$2 million lawsuit in U.S. District court charging that they were abused by police who mistook them for Indians. "The question involved in this suit is whether any state or local agency has the right to deny any person his civil rights on the ground he is an Indian," said Prof. William G. Rice, a constitutional law expert, who filed suit on behalf of Mr. and Mrs. William H. Delaney. The suit charged that the Delaneys were forced to stand 1-1/2 hours beside their car as police accused them of murder. When Delaney asked a policeman to take his wife to a nearby hospital, he was told, "Indians have no rights," the suit charged. Mrs. Delaney subsequently had a miscarriage on the road.

DO-IT-YOURSELF

NEW YORK - (NPI)--The City Commission on Human Rights has decided to handle its own discrimination charges against taxi drivers after the Police Hack Bureau dismissed charges against three taxi drivers accused of refusing to pick up Negroes. William H. Booth, commission chairman, accused Deputy Police Commissioner Edward J. McCabe, Hack Bureau director, of discrimination in dismissing the charges.

KLAN SIGNS

WASHINGTON - (NPI)--Mrs. Lyndon B. Johnson's national beautification campaign suffered a setback as 20 Ku Klux Klan recruitment posters were placed along Northern Virginia roads. "Help Fight Communism and Integration --Join the KKK," the 18-by-24-inch signs read. Arlington police removed the signs.

BIGOTS BOOTED

BALTIMORE - (NPI)--Pickets from the National States Rights Party were ordered out of racially-tense East Baltimore after Negroes hurled stones and bricks at them. Among the pickets was Charles Luthardt, white supremacist candidate for governor, who marched in front of CORE headquarters--only days after CORE picketed apartment buildings where Negroes are not wanted.

IOWA MARCH

WATERLOO, Iowa - (NPI)--About 250 Negro pickets complaining of police brutality, marched through this city's business district and presented 12 demands to city officials. They were seeking an investigation of the death of Eddie W. Sallis, a 23-year-old Negro found hanging in his jail cell. His death was ruled a suicide.

MEMORIAL WINNER

CHICAGO - (NPI)--A new lakefront park will be named after Pfc Milton Lee Olive III, recipient of the Medal of Honor, the nation's highest military award.

The award was conferred on the Chicagoan posthumously April 21 by President Johnson.

The city's new park, located near the Central District Filtration Plant, will be called Pfc Milton Lee Olive III park.

Olive died October 22 when he threw himself on a grenade in Viet Nam, thus saving the lives of four fellow soldiers. He was 19, and the eighth Negro in U.S. history to be awarded the Medal of Honor.

URGE EARLY TEACHER X-RAYS

Classroom teachers and other school employees who are required to have Tuberculosis x-rays for certification purposes, have been encouraged to take care of this matter during the early part of the summer vacation.

DR. H.R. GETZ, Supervisor of the TB Control Section, Nevada State Division of Health, Reno, will be on vacation during September and will be unable to provide any "last minute service," it has been reported.

Teachers are urged to have TB x-rays forwarded to the TB Control Section before September 1, Dr. Getz has advised. The usual amount of time required to process the x-rays is between three to four weeks, Dr. Getz said. A great number of x-rays are received in September.

It is even more important for teachers in this area to have this done as soon as possible since all the public schools operated by the Clark County School District will open earlier for the 1966-67 school year. Registration will be held August 26 and 29 with classes actually starting August 30. The earlier opening date will permit a longer spring vacation period.
