the department before he took over the artist post.

Some police departments use the composite picture system. The composite system is conducted by showing slides of a face with different types of eyes, noses and mouths. The witness is then asked to pick out the one which most closely resembles the wanted person.

Rathel shuns this system. He says he is able to get better results by his method. Knowledge of the suspect's age is an important factor. It lets one know how good a judge of age the witness is. He continued, "I ask if the face of the suspect is as large as mine or larger. I ask for the overall shape of the face, hair style, hair line, the eyes, the nose, tip of the nose, bridge of the nose, if the nose has been broken."

He explained that individual features may sometimes be vague and the witness can only recall an expression, so he concentrates a lot on the overall look. Speck was described by Miss Amurao as a gentile-looking person, who didn't seem like he would harm anyone.

Rathel is married and the father of two children. He resides on the Southside of Chicago. Asked to comment on youth and crime in the

present-day strife, he said, "I feel that a lot of kids who participate in gang warfare and breaking the law, should look in the mirror and take account of themselves. They wind up the losers in the violent game they play.

"Instead of taking the risks of being maimed for life, jail and even death, they should try to help with law and order. It is the only way we can survive. If they really want to become strong men, many should join their local police force. The experience would do them a world of good."

Meanwhile, the machinery of the law in Chicago and the County of Cook, is preparing its case for the prosecution of Robert Speck. The sketches of police artist Otis Rathel will play an important role in the procedure.
