er those charges had been made in the form of formal complaints.

MY QUESTION, Dr. West, is-Is it not true that "any and every", be it a municipality, a state, business, or organization have to be established as being in compliance with Covern tablished as being in compliance with Govern ment anti-discrimination policy before qualifying for Federal funds?

I am mindful, at this point, of the impact federal money had on a state's discriminatory practices, recently, when Illinois Governor Otto Kerner outlawed discrimination in the sale of housing by real estate brokers and salesmen after Atomic Energy Commission officials, who visited Weston, Illinois where a \$375 million atom smasher was to be located, reported they were not favorably impressed with the housing discrimination practiced in the area.

AEC officials were considering Denver as a site for the smasher, as the Colorado capital has an open housing policy. Governor Kerner's action was said to be an attempt to change their minds. Meanwhile, the NAACP has filed a complaint with the AEC with the formal charge that the area does have a long history of housing segregation.

I suppose you have read where the real estate brokers in Illinois are "some kind of put with the Illinois Governor. They have vowed they would challenge every denial of a real estate license in court. This reaction hardly comes as a surprise as real estate interests are notably the last bulwark of bigotry in this
