POTENT NEGRO VOTE PROVEN

MEMPHIS - (NPI) -- A forecast of the power the Negro vote will have in the nation's general elections was offered by events locally and in

Memphis' Negro vote was credited with being the swing vote which gave Gov. Frank Clement the renomination for re-election to his office. Gov. Clement—who won by 360,665 to 351,495 over U.S. Sen. Ross Bass--is said to have endeared himself to Negroes through the appointment of Ben Hooks, a Negro attorney, as a

county judge.

Meanwhile, five Louisiana parishes (counties) were ordered by a federal court to add 13,000 persons--most of them Negroes--to their voting rolls. Effect of the order was to put more Negroes than whites on the registration lists in East Carroll and West Feliciana parishes

in the primary election.

IN EAST CARROLL, in the northeast corner of the state, two Negroes were running for school board seats. The decision applies equally to East Feliciana, East Carroll, Plaquemines, Quachita, and West Feliciana parishes.

AT LEAST SIX NEGROES were nominated to the state legislature in the Tennessee primare.

to the state legislature in the Tennessee primary. Twelve others were elected in local elections to three county courts of magistrates (county government bodies). In Fayette county, seven Negroes were elected to the 37-member county court, the first Negroes to serve on

county posts since Reconstruction.

IN PETERSBURG, Va., increasing Negro voter strength in recent elections prompted a "white backlash" in the form of a group seeking to rally more white voters to the polls. Warning that "Negroes will control all future elections in the city' unless whites act, Herbert F. Talbott, of the new Citizens Voters League said the group was conceived after a Negro won a city council seat in the June 14 municipal election and a Negro-backed candidate won another seat in a runoff.

IN THE BEDFORD-STUYVESANT section of Brooklyn, 90 workers from Youth in Action, the local anti-poverty agency, knocked on tenement doors in an effort to find the 63 per cent of the 184,000 eligible voters they estimate are not registered.

MEANWHILE, Negro voter registration in the South advanced 16 per cent in a year, the Southern Regional Council reported. Negro registration in Alabama, Mississippi, Louisiana, South Carolina, Georgia, and Virginia was said to have increased from 837,000 to 1,289,000.

The percentage of Negroes registered to vote increased from 30 to 46 per cent in one year since the passage of the Voting Rights Act of 1965, it was reported.

One major setback was the Alabama governor's race, in which Mrs. George Wallace appeared to be headed toward certain victory. Republican prospects were dim in the state-and Alabama was sure to face many more years of Wallace racism.
