"STATE NEEDS NEW LAWS" - HILBRECHT

Las Vegas attorney, Norman Ty Hilbrecht, a candidate for one of the nine Assembly seats from Las Vegas has been a Las Vegas resident since 1939 and is a graduate of Las Vegas grade and high schools. He was graduated from Yale Law School with honors in 1959 and has been a practicing attorney in Las Vegas since his admission to the Bar also in 1959.

HILBRECHT GAINED state-wide esteem as permanent Chairman of the State Democratic Convention in Winnemucca last May. State Central Committee Chairman, Bill McDonald termed Hilbrecht's handling of the convention "masterful--with the greatest party unity and more accomplished than I've ever before seen".

Hilbrecht has earned the reputation of 'trouble shooter' for the local Bar Association, having served on more controversial committees than any other member. Presently he serves as Chairman of the Law Library Board of Trustees, Chairman of the Public Relations Committee, and Chairman of the Standing Committee on Legal Aid

Additionally, he is a member of the Medico-Legal Committee; is active in the American Trial Lawyers Association, and is President of the Nevada Legal Aid and Defender Association which he chartered. With the State Bar of Nevada, Hilbrecht has served two terms on the important Law and Legislation Committee. He also serves on the American Bar Committee on Legal Aid and Indigent Defense, and was Chairman of the ABA Special Committee on the Defense of Indigent Persons Accused of Crime.

RECENTLY, HILBRECHT was made chairman of an ad hoc Committee to study and make recommendations on the much criticized "Judicare" phase of the War on Poverty. The plan submitted by his committee providing for a full-time Legal Aid staff attorney won a 2 to 1 approval from the previously hostile Bar, and is now in the process of approval by the Office of Economic Opportunity.

Norman Ty Hilbrecht worked his way through college and Law School as a substitute postman during his summers here in Las Vegas. He is a Captain in the Army Reserve, and served as



legal officer to the 427th CA Company here for three years. In the Judge Advocate General's School at the University of Virginia, he completed his courses in military law with honors, and while an Infantry Officer won a commendation for his company for his instruction and leadership capabilities.

Hilbrecht stated that he decided to file for the legislature because "the State badly needs new laws and a responsible up-dating of some of the present statutes". "With my training and experience in the field of law and legislation", he continued, "I believe I am qualified to serve the State in that capacity. Areas of particular need include revamping the N.I.C. law to allow the Commission to make adequate awards and to broaden the area of coverage for industrial accidents and disabilities; bringing our minimum wage law up to the national standards, in view of the fact that ours is one of the highest per
