How I wish Benedict Arnold could have seen the reception Ralph Denton got from Las Vegas Negroes in two Westside appearances subsequent to the circulation of his trash. The greatest tribute was acknowledged him by wildly enthusiastic supporters in that not a single individual present even made reference to the dirty, rotten, low-down, nasty stinking effort to destroy the Negro electorate's trust and confidence in Ralph Denton. Rather, the attack is considered an insult to the intelligence of the Negro, and I am as proud of my people for the judgment they showed in instinctive rejection of the accusation as I am in the judgment they have exercised in the selection of Ralph Denton as the candidate of their choice for Congressman, as indicated by the unanimous endorsement given him by the Westside Voters League on Tuesday night.

For Nevada's number one ace Judas' information, we all know how Denton feels about the open housing provision of the Civil Rights Act. He shares the same feeling as expressed by the leaders of totally all Civil Rights organizations and of Negro legislators.

So that there can be no doubt as to what that opinion is, I offer a statement released on August 9, 1966 by Negro Congressman Adam Clayton Powell, Chairman of the House of Representative's Committee on Education and Labor captioned "POWELL NOT TO VOTE FOR CIVIL RIGHTS BILL OF 1966. Herewith is a verbatim reprint of that release.

Representative Adam Clayton Powell, Chairman of the Education and Labor Committee, said today that he could not vote for the Civil Rights Bill of 1966. The Chairman issued the following statement:

"Today in the United States, 70% of all black people live in urban areas. Of that percentage, it is estimated that 60% live in Northern cities.

Any legislative effort to better the continuing sorry plight of America's black man must, by definition, include a strong law on racial discrimination in housing.

Black people are no longer interested in "rights" but the IMMEDIATE exercise and enjoyment of these rights.

The current Civil Rights Bill before the House of Representatives, I deeply regret to say, in no way mitigates the housing caregation, slum housing and third-class residential pat-


