## Baring We'll Fix in '66

### OPEN HOUSE AT NEW SCOUT CENTER

The new Scouting Service Center of the Boulder Dam Area Council, Boy Scouts of America, will hold "open house" for the community on September 10. The facility, located at 1135 University Road, is directly adjacent to Nevada Southern University.

THE SERVICE Center, with a \$300,000 valuation, has been constructed to handle the day-to-day requirements of a Council area of almost 40,000 square miles including Clark, Lincoln and Nye Counties in Nevada, Mohave County (Kingman), Arizona, and Needles, California.

There are 9,000 Cub Scouts, Boy Scouts and Explorer Scouts in the Boulder Dam Area Council which has grown almost 50 per cent in the last two years. There are almost 3,500 adult volunteers associated with the Scout movement in the tri-state region as well.

The Service Center is a replacement facility for Scout offices previously located at 215 Mesquite in downtown Las Vegas. The previous site was sold to the State of Nevada for \$50,000 and will be used eventually for freeway access. An additional \$80,000 in budgeted building funds was borrowed to construct the new 8,500 square foot Service Center.

"ONE OF THE main objectives in holding the open house next month is to honor and ac-

knowledge the important contributions made by 87 building trades, suppliers and labor unions. These civic-minded groups donated considerable time and materials to help us keep our building costs to a minimum," said John Dupree, Scout Executive.

The Service Center, located on a four plus acre site donated by Robert Kaltenborn, is one of the most modern and functional Scouting facilities anywhere in the country. A few of the outstanding features designed to accommodate local Scouting's 15 full-time employees include:

Self-service supply center for literature, badges and special awards; Meeting Room to be furnished by a grant from the Las Vegas Rotary Foundation, Dr. Vincent Sanner, Chairman; Spaces for each district Scout executive; Adequate parking on both sides of the building; Employee's lunch facility; Landscaping coordinated by Garden Center and donated by the Resort Hotel Association; and Clerical work areas including duplicating/mail room.

A special luncheon has been planned for contributors at the time of the open house with Scouters, families and the general public to attend official ceremonies which have been scheduled for 2:30-6:30 p.m.

**LARGEST NEGRO BAPTIST GROUP TO "SOUL SEARCH" AT DALLAS MEET**

The National Baptist Convention, USA, Inc., the largest and one of the most widely respected Negro organizations in America, will assemble some 15,000 delegates and visitors September 6 through 11 in Dallas, Texas.

Dr. J. H. Jackson, president, will preside over this, the 86th national conclave. He will be assisted by his cabinet of officers and the 90-member board of directors. Theme of the convention will be "United We Stand." Delegates are expected to bolster their efforts for unity in view of the current civil rights controversy.

Dr. Jackson said reports and addresses "will reflect and emphasize the convention's basic philosophy in first-class citizenship and the philosophy of civil rights."

Delegates will pay tribute to a champion of civil rights, the late President John F. Kennedy, on Saturday, September 10, with a special memorial service for Kennedy at the site of his assassination. The service will be held from 1 to 2 p.m.

The convention will attempt to provide constructive answers to the following questions:

1. Have Negroes turned from religion en masse?
2. Do Negroes appreciate what they are and what they have produced?
3. Are the majority of Negroes anti-American, anti-white?
4. Are they dedicated to understanding and goodwill?

**FOOTBALL JAMBOREE**

Five Southern "AAA" Conference teams will launch the 1966 high school football season locally on Sept. 9 at Cashman Field with the first pre-season "sneak preview" Jamboree. Game time has been scheduled for 7:30 p.m. since 10, instead of the regulation four, quarters of action are on the docket. The Jamboree will be divided into two halves of five quarters each. The quarters will be of regulation 12 minute length.
