Office	Qualifications	Term	Salary	Duties
County Assessor	Qualified elector	4 yrs.	\$15,000 annually Beginning Jan., 1967	Assesses real and personal property within the county for the purpose of taxation.
County Treasurer	Qualified elector	4 yrs.	\$13,500 annually Beginning Jan., 1967	Receives and pays out all monies and invests idle funds.
District Attorney	Bonafide resident of Nevada. An attorney duly licensed and admitted to practice in Nevada.	4 yrs.	\$18,000 annually Beginning Jan., 1967	Acts as public prosecutor in felony cases within the county of his jurisdiction and in misdemeanor cases within unincorporated areas; legal counsel to elected county officials, departments, boards and commissions; may engage in private practice.
County Sheriff	Qualified elector	4 yrs.	\$17,000 annually Beginning Jan., 1967	Enforcement of State and county laws within the unincorporated areas, including traffic; collection of some fees and issuance of some licenses; membership in County Gaming and Liquor Control Board.
Justice of the Peace	Qualified elector	2 yrs.	Fees only	Sets bail for and tries persons accused of committing misdemeanors within the unincorporated area of the township, imposing fine or sentence when necessary; holds preliminary hearing in felony cases within the township; hears civil suits involving \$300 or less; upon presentation of request, issues or denies search warrants; performs marriage ceremonies.
School Board Trustee	Qualified elector Residence in the district he represents.	4 yrs.	No salary	Board determines policy of the district to best promote welfare of school children; hires the Superintendent; approves teacher contracts; administers oaths and affirmation of office; accepts gifts or bequests and determines their best use; holds public board meetings twice each month or as required.
Hospital Board Trustee	Qualified elector	4 yrs.	No salary	Board operates Southern Nevada Memorial Hospital; hires hospital administrator; prepares hospital budget; sets hospital policy.
County Library Trustee	Qualified elector	4 yrs.	No salary	May establish, supervise and maintain a library and reading room; establish by-laws and regulations for operation of library.
Constable	Qualified elector	4 yrs.	\$1200 annually + Fees for services	Serves papers, executes small claims, and acts as a collection agent.
Public Administrator	Qualified elector	4 yrs.	No salary. Income is derived from statutory estate fees	Receives and disposes of real and personal property of any deceased who dies intestate or has no heirs in Nevada.
